BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

 Corona Chamber of Commerce -\$750.00 – The funds were used for the 12th Annual Riverside County Women's Leadership Conference, which benefits men and women in Riverside County with leadership skills, medical panel updates, and confidence building.

- 2. Inland Valley Symphony \$5,000.00 The funding will be used for the Holiday Concert, and the concert venue at Temecula Valley High School with the Temecula Valley Youth Symphony students performing along with professional musicians. Attendees come from Southwest Riverside County, including Temecula, Murrieta, Menifee and Wildomar.
- 3. Inland Empire Men's Club \$1,000.00 The funds will be utilized for the Celebration of Reverend Dr. Martin Luther King, Jr., and the second annual scholarship breakfast. The event will focus on mentoring young men and women with life skills aiming to impower young people to become productive citizens.
- 4. Pearl Center of Creative Arts \$1,500.00 The funding will be used for the Teenealogy Tapestry Fest, a weaving of genealogy roots through art, an intergenerational program for teens and elders throughout the Murrieta School District.
- 5. Dresses and Dreams Project \$3,000.00 The funds will be utilized to assist teen girls who encounter financial hardships and difficult circumstances in their lives by providing free attire for proms and military balls.
- 6. Anza Community Building, Inc. \$16,200.00 The funding will be used for the Anza Community Building improvements, e.g., to install and upgrade energy efficient lighting, fans, speakers, and insulate the ceilings for more energy efficiency, as well as interior and exterior painting.
- 7. Rotary Club of Menifee \$5,000.00 The funding will be utilized as a fundraiser to support the programs and projects within the Menifee community. The projects and programs are to fight human trafficking, leadership training for high school students at Heritage and Paloma High Schools, as well as a food drives for seniors, and supporting the local women's shelter.
- 8. Friends of Valley-Wide Foundation \$2,500.00 The funds were used for Autumn Elegance, a fundraiser, which provides youth scholarship programs in the East Hemet and Valle Vista location, as well as recreation park improvements in Valle Vista, French Valley, and Winchester areas.
- 9. Tahquitz High School Band \$1,000.00 The funding will be utilized to support the Tahquitz High School Jazz Band by supplementing funds to disadvantaged students to attend a trip to New Orleans, where the students will perform multiple times at multiple venues, including Preservation Hall and the Amphitheatre at Washington Artillery Park.
- 10. Community First Church of God \$5,000.00 The funds will be used to support the Homeland Community Pantry for weekly distribution of food, serving 120 families a week.
- 11. Riverside County Office on Aging \$40,000.00 The funding will be utilized to supplement the Riverside County Office on Aging Material Aid Program, which serves senior residents in District 3 with home repair, prescription costs, utility bills, etc.
- 12. 5&2 Compassionate Ministry Wildomar \$4,200.00 The funds will be used for the Community Food Shelf distributions for residents who live in Wildomar, Murrieta and Menifee, serving 2,000 residents a year.
