



BACKGROUND:

Summary

The U.S. Department of Housing and Urban Development (HUD) requires that all substantial amendments to the County's Five-Year Consolidated Plan and the One-Year Action Plans are subject to the Citizen Participation Plan and are approved by the Board of Supervisors and HUD. In accordance with the County of Riverside's Amended Citizen Participation Plan for the 2019-2024 Five-Year Consolidated Plan (Citizen Participation Plan), all new activities added to a One-Year Action Plan, any significant increases in funding or changes to an existing project, or other changes or amendments to the 2019-2024 Five-Year Consolidated Plan are considered to be substantial amendments.

The proposed Community Development Block Grant (CDBG) projects warranting these substantial amendments have been determined by staff to be eligible activities that meet a National Objective of the Programs. A description of the proposed amendment to the 2023-2024 One-Year Action Plans is set forth in Attachments A, B, C, D, E, F, G and H.

Staff recommends approval of the new CDBG projects listed below as substantial amendments to the 2023-2024 One-Year Action Plans of the 2019-2024 Five-Year Consolidated Plan:

Pursuant to the California Environmental Quality Act (CEQA), the Substantial Amendments were reviewed and determined to be exempt from CEQA under State CEQA Guidelines Section 15061(b)(3), General Rule or "Common Sense" exemption. The Substantial Amendments are administrative planning documents that will only have financial and administrative effects. It can be seen with certainty that there is no possibility that the proposed Substantial Amendments may have a significant effect on the environment and will not lead to any direct or reasonably indirect physical impacts. The projects identified in the Substantial Amendments will be subject to separate CEQA environmental review prior to taking any choice limiting action or discretionary action on that specific project. Notices of Exemption for each project will be filed by County staff with the County Clerk within five days of the approval of the Substantial Amendments.

Furthermore, the Substantial Amendments were determined to be exempt from the provisions of the National Environmental Policy Act (NEPA) pursuant to Title 24 Code of Federal Regulations Sections 58.34 (a)(1) and (a)(3) since the proposed Substantial Amendments are administrative activities. The projects identified in the Substantial Amendments will be subject to separate NEPA environmental review prior to taking any choice limiting action or discretionary action on that specific project.

Pursuant to 24 CFR Section 91.105 and the Citizen Participation Plan, the Housing and Workforce Solutions Department published the required public notice notifying the public of the comment period for the proposed substantial amendments on November 1, 2023. No public comments have been received.

County Counsel has reviewed and approved to form the Substantial Amendments to the 2023-2024 One-Year Action Plans of the 2019-2024 Five Year Consolidated Plan.

Impact on Residents and Businesses

Home Gardens Library Improvement Project (CDBG): The Riverside County Office of Economic Development will use CDBG funds to pay for costs associated with the Home Gardens Library Improvement Project. Improvements include, but are not limited to, finishes (paint and carpet), furniture, playground surfacing and equipment, and restroom upgrades to the

areas specific to library services. CDBG funds will be used for design, construction, project management, compliance monitoring, inspection, and other related expenses.

Mecca Library Renovation Project (CDBG): The Riverside County Office of Economic Development will use CDBG funds to pay for costs associated with the Mecca Library Renovation Project. Improvements include, but are not limited to, study rooms, finishes (paint and carpet), furniture, building system and energy efficiency upgrades, and improvements in compliance with the Americans with Disabilities Act (ADA) standards. CDBG funds will be used to pay for the design, construction, project management, compliance monitoring, inspection, and other related expenses.

Lakeland Village Road Improvement Project (CDBG): The Riverside County Transportation Department will use CDBG funds to pay for cost associated with the construction of approximately 590' of road improvements on Nelson Street (between Baldwin Blvd and Bodkin Avenue) and on Bodkin Avenue (between Nelson Street and Hayes Avenue) in the unincorporated area of Lakeland Village. Both roads will be paved to a width of 24'. All improvements will take place within existing Right-Of-Ways (ROWs).

Good Hope Road Improvement Project (CDBG): The Riverside County Transportation Department will use CDBG funds to pay for cost associated with the construction of approximately 705' of road improvements on Main Street (between Terrace Avenue and Cypress Avenue) in the unincorporated area of Good Hope. Main Street will be paved to a width of 24', with a 25' unpaved median dividing the two travel lanes. All improvements will take place within existing Right-Of-Ways (ROWs).

Meadowbrook Road Improvement Project (CDBG): The Riverside County Transportation Department will use CDBG funds to pay for cost associated with the construction of approximately 2,567' of road improvements on Eugene Street (between Highway 74 and Theda Street) in the unincorporated area of Meadowbrook. Eugene Street will be paved to a width of 26'. All improvements will take place within existing Right-Of-Ways (ROWs).

Food Assistance Program (CDBG): Family Services of the Desert's Food Now program provides assistance to low-income individuals and families in need of emergency food in the City of Desert Hot Springs and surrounding areas. CDBG funds will be used for the purchase of food, space costs, and other program-related expenses.

City of Beaumont Pedestrian Sidewalk Safety Improvements Project (CDBG): The City of Beaumont will use CDBG funds for sidewalk improvements to improve pedestrian safety. Improvements include, but are not limited to, lighting, sidewalk installation, and curb repairs. CDBG funds will be used for design, engineering, construction, and project management expenses.
