BACKGROUND:

Summary

In recent discussions and public comment, a recurring theme has been the potential conflict of interest (or even the perception of a conflict of interest) involved in having the Coroner and the Sheriff as one entity.

The Sheriff and the Coroner's Offices had been separated in Riverside County for most of the County's history. In December 1995, however, the Board adopted a recommendation from the Riverside County Commission on Reorganization and Structure to consolidate the office of County Coroner-Public Administrator under the office of County Sheriff. The ordinance was adopted in 1996, with the integration occurring January 1st, 1999.

California is one of only three states that does not require the Sheriff and Coroner to be independent of each other. While there is no evidence of any improprieties in Riverside County regarding the operations of the Coroner's Office under the Sheriff, the optics of a potential conflict of interest can lead to a loss of confidence in our institutions.

The 2017-2018 Riverside County Grand Jury also looked at this issue, and recommended that as an alternative to separation, the Sheriff re-establish "an agreement with acceptable terms, with an adjacent County, to perform autopsies of in-custody deaths." Such an agreement had previously been in existence but had been allowed to lapse.

If passed, this item would ask the County Executive Office to evaluate options for separating the Office of the Sheriff and Coroner/Public Administrator again. This report would include potential costs, savings, legal issues, organizational structure, and labor considerations, and be returned to the Board within 90 days.

Impact on Residents and Businesses

Confidence in our law enforcement institutions and the perception of fairness are important goals, but before taking further specific steps, a complete cost/benefit analysis of options should be performed.

I appreciate the opportunity to address you today as I advocate for the separation of the Coroner's office from the Sheriff's office in Riverside County. This issue is of paramount importance, impacting transparency, accountability, and the pursuit of justice.

The urgency of this matter is underscored by a distressing incident involving Mr. Ernie Serrano, who tragically lost his life on December 15, 2020. Following this event, Riverside County Sheriff Chad Bianco attributed blame to Mr. Serrano based on a preliminary autopsy report. Unfortunately, the Connor's Report, crucial for understanding the circumstances of Mr. Serrano's death, remains undisclosed to this day.

My efforts to obtain the autopsy report have unveiled systemic issues within the current structure. A formal request was submitted to the Riverside County Coroner's office on May 7, 2021. However, subsequent inquiries on June 15 and August 4, 2021, revealed a concerning pattern of delays, with assurances that the report would be ready in two weeks, then two months. As we approach the three-year mark since Mr. Serrano's passing on December 15, 2021, the report remains elusive, prompting the troubling question of when justice will prevail.

The current structure, where the Coroner's office falls under the jurisdiction of the Sheriff's department, presents significant challenges to transparency and accountability. When the entity responsible for an investigation also determines the release of vital information, it creates an inherent conflict of interest.

Separating the Coroner's office from the Sheriff's office is not solely about this specific case; it's about ensuring a fair and impartial process for all. We need a system where investigations and reports are conducted without the specter of bias, where accountability is paramount, and where the public can trust that justice is diligently pursued.

This separation is a vital step toward rebuilding trust between the community and law enforcement. It empowers the Coroner's office to operate independently, enhancing the credibility of investigations and reports and fostering the transparency fundamental to a just society.

In conclusion, the time has come to reassess and restructure our current system. Separating the Coroner's office from the Sheriff's office is a necessary stride toward justice, accountability, and the rebuilding of community trust. Comments DECEMBER 5, 2023 RIVERSIDE BOARD OF SUPERVISORS MEETING PUBLIC COMMENTS Ladies and gentlemen,

I appreciate the opportunity to address you today as I advocate for the separation of the Coroner's office from the Sheriff's office in Riverside County. This issue is of paramount importance, impacting transparency, accountability, and the pursuit of justice.

The urgency of this matter is underscored by a distressing incident involving Mr. Ernie Serrano, who tragically lost his life on December 15, 2020. Following this event, Riverside County Sheriff Chad Bianco attributed blame to Mr. Serrano based on a preliminary autopsy report. Unfortunately, the Connor's Report, crucial for understanding the circumstances of Mr. Serrano's death, remains undisclosed to this day.

My efforts to obtain the autopsy report have unveiled systemic issues within the current structure. A

formal request was submitted to the Riverside County Coroner's office on May 7, 2021. However, subsequent inquiries on June 15 and August 4, 2021, revealed a concerning pattern of delays, with assurances that the report would be ready in two weeks, then two months. As we approach the three-year mark since Mr. Serrano's passing on December 15, 2021, the report remains elusive, prompting the troubling question of when justice will prevail.

The current structure, where the Coroner's office falls under the jurisdiction of the Sheriff's department, presents significant challenges to transparency and accountability. When the entity responsible for an investigation also determines the release of vital information, it creates an inherent conflict of interest. Separating the Coroner's office from the Sheriff's office is not solely about this specific case; it's about ensuring a fair and impartial process for all. We need a system where investigations and reports are conducted without the specter of bias, where accountability is paramount, and where the public can trust that justice is diligently pursued.

This separation is a vital step toward rebuilding trust between the community and law enforcement. It empowers the Coroner's office to operate independently, enhancing the credibility of investigations and reports and fostering the transparency fundamental to a just society.

In conclusion, the time has come to reassess and restructure our current system. Separating the Coroner's office from the Sheriff's office is a necessary stride toward justice, accountability, and the rebuilding of community trust. Together, let us work towards a system that upholds the principles of fairness, transparency, and, above all, justice for all.

I am calling in to support of item number 29 because we cannot let our community members continue to suffer at the hands of the Riverside County Sheriff. One step in accomplishing this is by taking steps to separate the sheriff and coroner's office and improve access to unbiased and accurate information regarding in-custody deaths.

To add, the attorney general's office released data bringing last year's total in-custody deaths to 19. The sheriff's department had not logged more than 12 deaths in a year since 2005, the earliest year for which records are publicly available. Last year's death toll was also slightly higher than the number that triggered a state investigation in the more populous San Diego County the year before. Some of these deaths were not properly reported within the timeframe required by law to the California Department of Justice.
