



Summary

This action declares this vehicle surplus and seeks approval to donate one (1) used vehicle with 158,927 miles to Palm Desert Sister Cities Foundation, a non-profit organization operating out of Palm Desert located at 73-401 Terraza Drive, Palm Desert CA 92260. Palm Desert Sister Cities Foundation was established to develop economic, cultural, and technical exchanges between US cities, counties, and states and with corresponding communities worldwide. Palm Desert Sister Cities Foundation focus on humanitarian and public safety projects worldwide.

Currently, this used maintenance vehicle is being stored at 44-199 Monroe Park, Indio CA 92201 and it would be more efficient and cost effective for the County to donate this vehicle to Palm Desert Sister Cities Foundation rather than to pursue the cost and effort of a surplus sale of this vehicle that is no longer needed by the County due to age and wear. This vehicle is fully depreciated.
