BACKGROUND:

Summary

On Tuesday, April 5, 2022 via Agenda Item 3.11, the Board of Supervisors of Riverside County approved the Department of Public Social Services Administration 1st Floor Finishes Replacement (DPSS Admin 1st Floor Finishes Replacement) Project for inclusion in the Capital Improvement Program in the amount of \$1,043,152.

The Department of Public Social Services Administration facility located at 4060 County Circle Drive in the City of Riverside was constructed in 1987. The facility's 1st floor required the replacement of aged and worn finishes due to the age and wear in the flooring and restrooms. The scope of work for the project included but was not limited to the replacement of carpet and tile, installation of new restroom fixtures and countertops, toilet partitions and re-painting of the entire floor.

The project was completed in May 2023. DPSS is required to claim expenses back to the State over three fiscal years. DPSS made an initial payment of \$270,531.68 to County Facilities Management in FY 22/23. DPSS obtained financing for this project through JP Morgan Chase Bank N.A. for the remaining two years.

With Board approval, this item will authorize the Purchasing Agent to issue Purchase Orders to JP Morgan Chase Bank N.A. for the bank financing for the DPSS Admin 1st Floor project in FY 23/24 and 24/25.

Impact on Residents and Businesses

The DPSS Admin 1st Floor Finishes Replacement Project will improve the environment of the program clientele and the staff.
