BACKGROUND:

Summary

The County of Riverside contracts with vendors throughout the county to provide legal services for indigent defendants for whom the Riverside County Law Office of the Public Defender declares a conflict of interest or is otherwise unavailable. New contracts for these services were put into effect July 1, 2023. At the time of Fiscal Year 2023-24 budget adoption, the contract amounts were unknown. A ten percent (10%) increase was budgeted as an estimate. Final contract amounts were ultimately much higher due to inflation and the need for increased service levels. Current projections reflect the need for an additional \$2 million in appropriation to meet demands for Fiscal Year 2023-24.

There is also a need for Court Reporter funding. Judges in Superior Courts may make motions directing the county to pay for creating a verbatim record in criminal matters, appeals, juvenile proceedings, proceedings to declare a minor free from custody, probate proceedings and some civil matters. The adopted budget for these fees paid to court reporters was based on the prior three-year average. However, trials have steadily increased as the Courts ramp back-up to prepandemic workloads resulting in increased costs to this budget unit. Current projections reflect the need for an additional \$350,000 in appropriation to meet demands for Fiscal Year 2023-24.

Impact on Residents and Businesses

Providing these services allows the County to provide constitutionally mandated legal services to its constituents and provide attorneys the support to help meet their requirement to provide an adequate defense.

Additional Fiscal Information

The Executive Office requests \$2.35 million from general fund contingency for the current fiscal year as there are not sufficient departmental funds for projected expenditures in Fiscal Year 2023-24.
