BACKGROUND:

Summary

Lunch at the Library is a project of the California State Library, supported with funds from the State of California, and was developed by the California Library Association and the California Summer Meal Coalition. The summer lunch program is offered in low-income communities where more than 50% of youth qualify for free and reduced-price school lunch programs.

\$294,848 in Core program funds will allow the Riverside County Library System (RCLS) to establish and serve United States Department of Agriculture (USDA) summer meals at library site(s) as well as pop-up sites at community centers, apartments and other community partner locations, and provide learning and enrichment programming at those meal sites. The award will be used to purchase operational supplies, equipment, and programming. The library programming includes learning and enrichment activities, nutrition education, workshops and presenters supporting summer learning and summer discovery. A portion of the funds will also be used to support Library staff time for program implementation. Additionally, the funds will support youth development through the establishment of a teen internship program offering teens an opportunity to gain leadership and workforce readiness skills as they assist staff with the work involved in providing programming and meals at participating sites. Teens will participate in resume writing workshops, earn their food handling certificate and more. Lastly, funds will be used to provide books to help participants establish home libraries.

\$200,000 in Innovation funds will be used to broaden outreach to those in the community who do not typically think of libraries as a destination for exciting programs through the development of a large-scale effort of publicity via digital billboards, theater movie trailer advertisement and through bus wraps and social media. These funds will be used to enhance and promote the vast array of programming available at local libraries beyond the historical understanding of libraries as locations to simply check out books.

Impact on Residents and Businesses

Grant award funds will be used for various programs, bringing noted children's authors to our libraries for readings and book signings, connecting children with their favorite authors, and building excitement around the library and reading.

Approval of the recommended actions will also allow the County Librarian to accept and execute the grant agreement, allowing the Library to meet time-sensitive grant requirements to fully
