

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The Women's Summit will be held at Veterans Memorial Park in the City of Coachella on March 30, 2024. The inaugural event hopes to ultimately provide meaningful connections, exposure and communication, inspiration, and knowledge, establish new collaborations, and personal/professional growth. The Women's Summit consists of a full day of immersive programming, networking, health & wellness activation stations and more. CID funds will be used to help cover equipment, food, marking and supply expenses.

2. College of the Desert Foundation hosted their Annual State of the College at the Toyota of the Desert Showroom on February 29, 2024. CID funds will be used to support the Fund for Student Success program.
3. Desert Recreation Foundation will host their 3rd Annual Bowling Tournament on Friday, March 22 at the Fantasy Lanes, in Indio. Proceeds from this event goes towards the Financial Assistance program which helps families and individuals participate in Desert Recreation District activities and programs at reduced or no cost. CID funds will benefit the Financial Assistance Program.
4. The Riverside County Youth Commission will host their 26th Annual Youth Summit on April 26, 2024, in Temecula. Each year high school students throughout the county convene to discuss topics that are affecting their lives and communities. The event is filled with guest speakers, educational workshops, and food. CID funds will be used to help with the cost of transporting students.
5. The Rotary Club of Indio will host the annual Rotary Math Field Day Competition on April 20, 2024. This event has several benefits, which include fostering math skills as a fun subject, and allows students to apply their math skills outside a classroom. CID funds will be used to purchase lunch and snack for students and volunteers.
6. The American Outreach Foundation offers the Donate Your Powerchair program, which provides veterans and seniors with mobility devices, electric wheelchair or scooters. The funds will be used to partially cover the costs of pickup/delivery powerchairs, refurbishing materials, batteries, and other miscellaneous program costs like maintenance calls and repairs.
7. Inland SoCal United Way will host their 2024 Annual Gala on March 15, 2-24 at the Agua Caliente Casino Resort Spa. The event will raise funds to support their family assistance programs, including Emergency Rental Assistance, and the Guaranteed Pilot Program for pregnant woman and transitional age foster youth.
8. The Riverside Sheriffs Association and the Riverside County Deputy Sheriff Relief Foundation will host a golf tournament Tee Up for Charity, on March 15, 2024, at the Eagle Glen Golf Club. Funds raised at the event will aid families of recent fallen officers who were killed in the line of duty and will assist the families during a crisis situations including catastrophic or life-threatening illness or death of an immediate family member.
