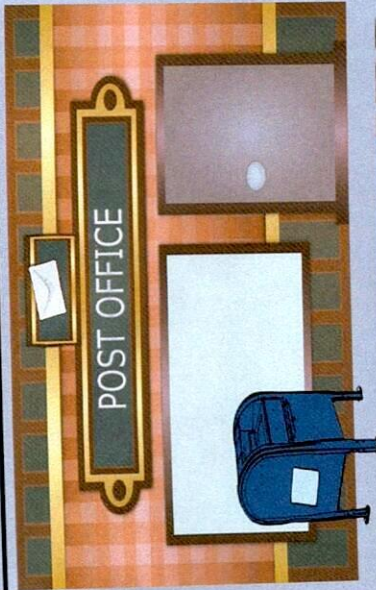
QUESTIONS AND CONCERNS FROM THE PUBLIC COMMENTS:

1. **Special session** A special session is needed, including Sheriff Bianco and Art Tinoco, in order for the community to learn what the supervisors know about our election system and how they plan to address its problems.
2. **Dominion Voting machines**
 - a. Professor Halderman recently hacked a voting machine, the same as those we are using, with a pen and a card in front of Judge Amy Totenburg in Georgia
 - b. The Dominion manual says you cannot set up the voting machine unless it is connected to the internet
 - c. The machines have foreign parts so they do not comply with the DOJ standards for critical infrastructure
 - d. The county signed a contract with Dominion that prohibits the county from inspecting the voting machine. Because of this prohibition, Sheriff Bianco says he has no way of knowing if the machines are manipulating the vote counts.
 - e. After hearing concerns about the Dominion machines, the county still decided to renew its contract with Dominion.
3. **Voter rolls**
 - a. The supervisors cannot guarantee an honest election unless the voter rolls are accurate.
 - b. Anyone can be registered on-line without any ID. Does the ROV have a process to catch fraudulent ballots being voted by those who register on-line?
4. **More votes that voters** in the 2022 elections
 - a. In the 2022 Primary there were 22,564 votes counted at the vote centers and 36,033 counted by the machines. There were 217,000 votes counted at the post office and 252,661 counted by the machines. According to HAVA, that election should not have been certified by the supervisors.
 - b. The ROV knew these discrepancies before certifying the 2022 elections: did the supervisors know?
5. **Illegal ballots received** Many reported receiving multiple ballots or ballots for family members no longer living in the state. There are former residents who have moved out of state that are still receiving ballots. What system is in place to prevent illegal ballots being mailed and counted?

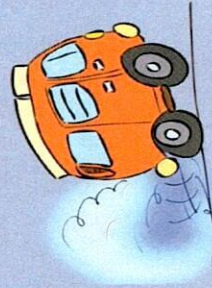
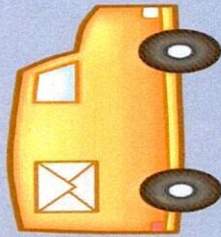

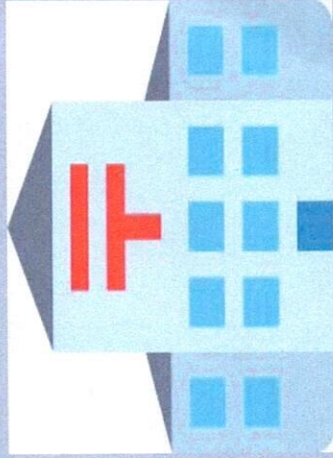
