

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **California Family Life Center - \$1,000** - will support the logistics and operating costs behind the benefit dinner and silent auction, "Our Family, Our Future," which raises funding to assist with gaps in funding, including counseling, food, shelter, and clothing.
2. **Riverside County Fire Department - \$2,000** will be used to support costs for the Student Fire Career Expo.
3. **Vivian Stancil Olympian Foundation, Inc. - \$3,000** will be used to provide water safety and swim lessons for children, youth and adults.
4. **TreePeople - \$67,365** will be used to distribute 350 trees to the residents of the Good Hope community.
5. **Riverside County Department of Animal Services- \$21,000** will be used to support mobile Spay & Neuter Clinics in the Good Hope, Mead Valley and Highgrove Communities.
