BACKGROUND:

On November 17, 2020, the Riverside County Board of Supervisors (Board) directed the Executive Office to implement an Unincorporated Communities Initiative (UCI). The UCI is a focused, ongoing, and coordinated effort to improve the infrastructure and services provided to the residents of unincorporated communities, with emphasis on Disadvantaged Unincorporated Communities. The program is funded through County General Funds which are budgeted annually to the Unincorporated Community Fund.

On December 15, 2020, the Executive Office presented a proposed framework for planning and implementation of the UCI. With the support of the Board, the Executive Office established a team of staff and department heads to facilitate the UCI program. Through March 31, 2021, the Executive Office Team held 15 community meetings and conducted online surveys to better understand community needs for services, infrastructure, and infrastructure maintenance. On May 25, 2021, the UCI Team presented the needs assessment to the Board.

On June 27, 2023, the Board adopted the FY23/24 Budget, which included the allocation of \$10,000,000 in General Funds to the Unincorporated Communities Fund. The \$10,000,000 was to be divided evenly between the five Supervisorial Districts for each Supervisor's use within their unincorporated communities.

Based on the foundational work completed by the UCI Team, the recommendations of the Transportation Land Management Agency, and further analysis by this office, \$2,000,000 in UCF funding for the First District will be allocated to the following projects in the Good Hope and Lakeland Village communities. The \$2,000,000 will be distributed between these projects as needed to complete them:

- **1. Floral Avenue** Paving Floral Avenue from Read Street to Palm Street in Good Hope.
- Cypress Avenue Paving Cypress Avenue from Baxter Street to Main Street in Good Hope.

- **3. Terrace Avenue** Paving Terrace Avenue from Read Street to Main Street in Good Hope.
- **4. Phillips Street** Paving Phillips Street from Mapes Road to approximately 350 feet southerly of Estrella Lane in Good Hope.
- **5. Ginger Lane** Paving Ginger Lane from Grand Avenue to end of Right of Way in Lakeland Village.
- **6. Undedicated Dirt Road** Paving Undedicated Dirt Road from Grand Avenue between Marvella Lane and Skylark Drive in Lakeland Village.
- 7. Richard Street- Paving Richard Street from Grand Ave to End in Lakeland Village.
- 8. Danny Lane Paving Danny Lane from Grand Ave to End in Lakeland Village.

Impact on Residents and Businesses

These projects will enhance infrastructure service levels to residents in Lakeland Village, Good Hope, and Meadowbrook. The projects reflect strongly stated community preferences for paving private streets and bringing them into the County maintained road network.

The long-term goal of the Unincorporated Communities Initiative is to improve infrastructure and services to all our unincorporated communities. This is another early step to meeting that commitment.

This funding allocation continues to prioritize the paving of dirt roads throughout the unincorporated areas from various sources in the First District, as seen in the attachment.
