BACKGROUND:

Summary

By Minute Order dated December 12, 2023 (Agenda Item 3.63), the County of Riverside Board of Supervisors authorized the Clerk of the Board to advertise for the construction of the MacKay Drive Sidewalk Project. The limits on MacKay Drive are from Marian Avenue to Union Avenue in the community of Lakeland Village.

The project consists of improvements on MacKay Drive that include new curb, gutter, and sidewalk to fill in an existing sidewalk gap on the south side of MacKay Drive; thus, extending the limits of the existing sidewalk. The sidewalk will provide an enhanced pedestrian path for travel to and from the adjacent Lakeland Village Community Center.

Additionally, the roadway segment of Mackay Drive between Marian Avenue and Union Avenue will be resurfaced on the north half width and reconstructed on the south half width. The reconstruction treatment consists of removing the existing asphalt concrete pavement and underlying material and placing back new Hot Mix Asphalt (HMA) pavement. The resurfacing treatment will require grinding down a portion of the existing asphalt concrete pavement followed by overlaying back with HMA.

Other improvements include construction of Americans with Disabilities Act (ADA) compliant concrete access ramp at the intersection of MacKay Drive and Union Avenue, concrete cross gutter, and residential concrete driveway approaches.

On November 17, 2020, the Riverside County Board of Supervisors directed the Executive Office to implement an Unincorporated Communities Initiative (UCI). The UCI is a focused, ongoing, and coordinated effort to improve the infrastructure and services provided to the residents of unincorporated communities, with emphasis on Disadvantaged Unincorporated Communities. Through March 31, 2021, the Executive Office team held 15 community meetings and conducted online surveys to better understand community needs for services, infrastructure, and infrastructure maintenance. Based on the foundational work completed by

the UCI team, the MacKay Drive Sidewalk Project was selected as a recipient of these funds (Minute Order 3.2 of the 8/30/22 Board of Supervisors Meeting Agenda).

EVMWD has accepted the bid prices proposed by Roadway Engineering for Alternative Bid Schedule 1 which includes adjustments of four (4) sewer manhole covers, and the cost for the work will be reimbursed by EVMWD through reimbursement Agreement. The Director of Transportation has the authority to sign reimbursement Agreements up to \$100,000 per Minute Order dated November 19, 2019 (Agenda Item 3.25).

The contractor, Roadway Engineering, is qualified to perform the work as outlined in the bid, has executed the contract, and has provided bonds and insurance documents which meet the requirements of the contract documents.

Impact on Residents and Businesses

The purpose of this project is to enhance the existing pedestrian path and to provide an Americans with Disabilities Act (ADA) compliant path along MacKay Drive. The new sidewalk will serve as a path to and from the Lakeland Village Community Center located adjacent to MacKay Drive.

The work is scheduled to begin in spring 2024 and will take approximately one month to complete.

SUPPLEMENTAL:

Additional Fiscal Information

Construction is expected to be completed in Fiscal Year 2023/2024 and will be funded with Gas Tax/HUTA, Unincorporated Communities Initiative Funds, and Elsinore Valley Municipal Water District funds.

The proposed budget as shown on Attachment "A" includes Contract award amount and other associated costs.

There are no General Funds used in this project.

Contract History and Price Reasonableness

A total of six bids were received on Wednesday January 10, 2024 ranging from \$329,474 to \$639,000. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsive and responsible bid was submitted by Roadway Engineering in the amount of \$329,474 which is \$17,529 (5.6%) above the engineer's cost estimate.

The Transportation Department recommends the award of the contract to Roadway Engineering in the amount of \$329,474.

- A. The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
- B. All work done according to the Contract, prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
- C. The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".




