

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. **The Fruit of Our Hands Ministries - \$3,000** will be used to support efforts to assist low income and at-risk families with financial literacy, credit repair, adult education, tutoring, empowerment classes, career path assistance and mentoring.
2. **The Grove Community Church - \$20,000** will be used to support local programming, services, community clean-ups, and translating services for the Municipal Advisory Council meetings in the Good Hope community.
3. **The Grove Community Church - \$30,000** will be used to support local programming, services, community clean-ups, and translating services for the Municipal Advisory Council meetings in the Mead Valley community.
4. **Riverside County District Attorney's Office - \$3,000** will be used to support outreach and awareness to the public by hosting events throughout the County for National Crime Victims' Rights Week.
5. **Riverside University Health System Foundation - \$2,500** will be used to purchase specialized equipment and training for the Riverside County Child Assessment Team Center at Riverside County Health System Medical Center to serve victims and families of child abuse.
6. **Mary S. Roberts Pet Adoption Center - \$3,000** will be used to support their mission of eliminating the suffering of homeless cats and dogs by providing humane care for pets in transition. The center is a partner of the Riverside County Department of Animal Services.
