## C.E.O. RECOMMENDATION: Approve

## BACKGROUND: Summary

The Board of Supervisors adopted new boundary maps on December 7, 2021. The new supervisorial districts go into effect in two phases as supervisorial elections occur, once in January 2023 and again in January 2025.

As a result of the March 5, 2024, primary election, voters have re-elected Supervisor Chuck Washington to represent the new 3<sup>rd</sup> Supervisorial District. Transitioning constituent concerns and administrative duties to Supervisor Washington for all communities within District 3 at this time will provide District 3 constituents with smooth continuity in representation once the new boundaries fully go into effect in January 2025. This includes the communities of DeLuz, La Cresta, Tenaja, and the City of Wildomar that were previously part of District 1, and the City of Menifee and community of Romoland that were previously part of District 5.

## Impact on Residents and Businesses

The recommended action will provide clarity and a smooth transition for constituent concerns and administrative purposes regarding County representation to the residents, businesses, and government agencies living or working in the affected areas until the new supervisorial boundaries fully take effect in January 2025.
