### The Need for New California to become the 51stState

The U.S. Declaration of Independence of 1776, the Alta California Declaration of Independence of 1836 and the Sonoma Proclamation of 1846 declared the Right of the People in the states of Alta California and California respectively to throw off the bonds of tyranny.

#### Constitutional Authority to Act

The current state of California has become governed by a tyranny, which rivals those expressed in the above documents. ### Article IV Section 3 of the United States Constitution

### United States Declaration of Independence

"Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such Principles and organizing its Powers in such form, as to them shall seem most likely to effect their Safety and Happiness".
