BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Riverside County Department of Facilities Management - \$10,350** will be used to purchase a tractor sweeping implement to be used at the Lakeland Village Community Center and Perret Park.
2. **Wildomar Community and Parks Foundation - \$9,200** will be used for the Wildomar Parks Safety Upgrades Initiative to replace wood mulch with a foam surface at the Marna O'Brien Park in Wildomar.
3. **Studio 395 Foundation, Inc. - \$20,000** will be used to support local programming, services and maintenance upgrades in the Lakeland Village Community.
