**BACKGROUND:**

**Summary**

On June 22, 2004, Agenda Item 3.1, the Board of Supervisors approved Resolution 2004-285 establishing the Temescal Valley Community Fund. The funds are to be used to the benefit of the residents of the Temescal Valley Community. The Second District, in conjunction with Trilogy at Glen Ivy Community Services and the Trilogy Veterans Club, desires to use \$8,000 of the Temescal Valley Community Fund for the construction and installation of a veteran's memorial wall within Trilogy. The memorial wall will feature the names of veterans who have served our country and have ties to the community. The Trilogy Veterans Club, a non-profit organization, will coordinate this work.

**Impact on Residents and Businesses**

Creation of a memorial wall within Trilogy will not only honor the veterans who have served our country and community, but also provide a meaningful and lasting tribute for generations to come.

**Additional Fiscal Information**

The settlement agreement and resolution establishing the Temescal Valley Community Fund in 2004 called for the Department of Environmental Health (DEH) to be the custodian of this special revenue fund. As such, expenditures authorized by the Board of Supervisors entail payment directly out of this fund without the need to adjust the budget of DEH.
