BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Lideres Campesinas' mission is to strengthen the leadership of farmworker women and youth so they can be agents of economic, social, and political change to ensure their human rights. Lideres Campesinas held a 3-day statewide convening in April 2024, which gathers farm-working women across California to participate in workshops and discussion regarding the state of farmworkers, agriculture, and various other social issues. CID funds will help with the cost for 15 farmworker women from the Coachella Valley to attend the convening.
- 2. The Regional Access Project foundation serves as the fiscal agent for Codex Creation Committee (CCC). The Mobius Conference is held annually to provide spaces for intellectual exchange on important revolving topics. This event brings together community leaders, heads of industry and students for diverse programming designed to empower and educate. CID funds will assist with the cost of transportation for students.
- 3. The Fourth District Youth Advisory Council will host Career Discovery Day in May 2024. This event invites public and private sector industries as motivational speakers to motivate and encourage young students to follow their goals, it also gives them an opportunity to network. CID funds will be used to help cover the expenses like table rentals, food and swag bags for students.
- 4. The Riverside County Office of Education honored high school seniors in the desert-area schools districts, including Coachella Valley, Desert Sands and Palm Springs Unified School Districts, and RCOE community schools from October to April. These Students of the Month are eligible for the prestigious Student of the Year Award, based on their outstanding academic achievements, and active participation in high school life. CID funds will assist with student scholarships to help pursue further educational opportunities.
