### BACKGROUND:

### Summary

The use of technology devices and social media is integral part of our daily lives, and more technology-based crimes are being committed. The Riverside Sheriff's Office (RSO) Major Crimes Bureau (MCB) is comprised of the Central Homicide Unit, Force Investigations Detail, Computer and Technology Crime High Tech Response Team, Crime Analysis Unit and the Forensics Unit. These investigative teams are supported by crime analysts who provide statistical and investigative support. To investigate technology-based crimes, the crime analysts utilize various databases and investigative tools to collect, extract and analyze data from phones and social media devices to aid an investigation. The ability to analyze call detail records and various forms of location-based data to identify patterns of criminal behaviors and/or relationship between data point is critical to prosecute crimes.

The Department recently purchased GeoTime Desktop and PenLink PLX Analysis Suite, both of which when combined support virtually any type of communications data from live collection or historical sources. GeoTime Desktop offers 3D mapping tools to show time and space to uncover details that otherwise may have been hidden through conventional 2D mapping. It also provides instant interactive visualization analysis, mapping, and reporting of geo-temporal data. PenLink PLX analyzes historical and live cellphone and social media account data in a single interface. The combined use of these applications enables the analysts to visualize nefarious behavior through cellular geo-temporal device activity in real-time in one comprehensive platform.

Over the years, RSO has purchased various mapping and analysis subscriptions from Uncharted Software Inc. (DBA GeoTime) for criminal investigations and surveillance operations and from PenLink, Ltd. for digital evidence software support. When PenLink, Ltd. acquired GeoTime, the annual costs for these of these subscriptions exceeded \$50K requiring Board approval. RSO is requesting to purchase additional licenses/subscriptions to conduct their investigative research, and the latest request is the GeoTime Live Agency Subscription for unlimited users.

### **Contract History and Price Reasonableness**

PenLink is offering Law Enforcement Legacy pricing to the Sheriff's Department. The cost for the GeoTime Desktop concurrent (floating) maintenance has not increased within the past five years.

RSO is requesting to purchase the GeoTime Live subscription for \$11,999 for unlimited users. Through our negotiation, PenLink is offering this subscription at a fixed cost for 5 years. In addition, starting FY 24/25 RSO plans to switch the PenLink PLX Analysis Suite (6 licenses) to the perpetual pricing model in which the initial annual cost will be is \$58,405 and \$13,783 subsequently for every year after. RSO is requesting to pay the perpetual license fee structure as this option will yield a cost saving over time since the renewal cost will be for \$13,783, instead of the previously approved \$23,904 annually.

The total 5-year cost for all the applications and subscriptions is \$245,103. RSO is requesting an aggregate 20% contingency of \$49,021 to cover additional users and licenses, software updates, and maintenance over the five (5) years. The aggregate five-year cost with the contingency will total \$294,124.

This SSJ will also supersede previously approved SSJ #24-081.

### Impact on Residents and Businesses

To protect the public, RSO requires access to the latest investigative tools to solving cases. The use of these subscriptions will improve RSO analysts' ability to extract pertinent information from cellular devices for criminal investigations and courtroom presentation.
