BACKGROUND:

Summary

The District's Board approved a contract with the Contractor in the amount of \$2,745,351 as Agenda Item Number 11.1 on May 2, 2023. The District's Board then approved Contract Change Order No. 1 in the amount not to exceed \$580,040 as Agenda Item Number 11.3 on October 17, 2023 and increased the total contract to \$3,325,391.

The Bautista Creek Channel Basin Sediment Removal Project consists of excavating and removing accumulated sediment to the original grades of the existing basin to restore the basin's capacity and function. The Project is located in the unincorporated Valle Vista region of Riverside County.

Final inspection of the Project was made, and the Project was found to be complete according to plans and specifications. A brief Project description and location map is attached. The final price for the contract is \$3,319,531, which is below the increased contract amount.

The District does not anticipate any claims for additional compensation from the Contractor.

Impact on Residents and Businesses

This Project involved excavating and removing accumulated sediment to the original lines and grades. This excavated material allowed the District to restore the basin's capacity and function which improves flood protection and public safety in the Project vicinity, downstream properties, and drainage facilities.

Pursuant to Public Contract Code 21091, invitation of sealed bids was solicited by advertising in print and digital media.

The final price for the contract is \$3,319,531, which is below the increased contract amount.
