BACKGROUND:

The applicant for Tract Maps 30976 and 30977-1 is requesting the conditional vacation of, Busby Road, Spiro Road and portions Ano Crest Road and Leon Road in the Winchester area to satisfy prior to map recordation Conditions of Approval. Tract Maps 30976 and 30977-1 are mapping over Ano Crest Road, Busby Road and Spiro Road and will be dedicating replacement rights-of-way and reconfiguring the roads in this area. A portion of Leon Road is being mapped over and realigned to conform to the Circulation Element of the General Plan alignment.

On March 19, 2024, Minute Order 3.20, the Board of Supervisors of the County of Riverside duly and regularly adopted Resolution No. 2024-043, giving notice of intention to conditionally vacate Busby Road, Spiro Road, and portions of Ano Crest Road and Leon Road.

Ano Crest Road, Busby Road and Spiro Road are dirt non-County Maintained roads dedicated for public street and public utility purposes by Parcel Map No. 11783, on file in Book 69, pages 57 through 59 inclusive of Parcel Maps, and accepted for public use by Resolution No. 84-002, recorded February 03, 1984, as Instrument No. 23636. Leon Road is a dirt County Maintained road dedicated and accepted for public street and public utility purposes by Parcel Map No. 11783, on file in Book 69, pages 57 through 59 inclusive of Parcel Maps and adopted for County maintenance by Board Resolution, dated February 24, 1948, on file in Supervisors Minutes Book 40, Pages 238 through 240, inclusive, as shown in the 1948 Riverside County Road Book, all records of Riverside County.

The vacation of Busby Road, Spiro Road and portions Ano Crest Road and Leon Road will be conditional. The vacation of Busby Road, Spiro Road and portions Ano Crest Road shall not be effective until the final maps of Tract Map 30976 and Tract Map 30977-1 have been recorded by the County of Riverside. The vacation of a portion of Leon Road shall not be effective until the final maps of Tract Map 30976 and Tract Map 30977-1 have been recorded by the County of Riverside, existing utilities in the portion of Leon Road to be vacated have been relocated and the construction of realigned Leon Road has been completed and issued a Notice of Completion by the County of Riverside.

The Transportation Department, Planning, Flood Control, and Cal fire have reviewed the proposed vacation and have no objection and the applicant has provided Vacation/Abandonment Approval Letters from the local utility companies. Twenty-seven (27) property owners in the project area have been notified of the proposed vacations; seven (7) responded in favor of the vacation, two (2) responded opposed to the vacation, and eighteen (18) did not respond.

This vacation was presented to the Planning Commission on January 17, 2024. The Planning Commission approved staff recommendation that the Transportation Department move forward with the process to vacate Busby Road, Spiro Road and portions Ano Crest Road and Leon Road.

Pursuant to California Streets and Highways Code Section 8320 et seq., the Board of Supervisors (Board) shall hold a public hearing to determine whether the vacation of the aforementioned roads are unnecessary for present or prospective public use prior to vacation. If the Board finds, from all the evidence submitted at the hearing, that the aforementioned roads are unnecessary for present or prospective public use, the Board may adopt the resolution vacating such roads. The resolution of vacation may provide that the vacation occurs only after conditions required by the legislative body have been satisfied.

This vacation has been determined to not be a project as defined under State CEQA Guidelines section 15060(c) and exempt pursuant to Section 15061(b)(3). However, even if it was determined to be a project under CEQA for analysis purposes, the project is exempt from the provisions of CEQA specifically by the State CEQA Guidelines as identified below. No unusual circumstances or potential cumulative impacts would occur that may reasonably create an environmental impact. The vacation of this street will not have an effect on the environmental; thus, the County has deemed this does not meet the definition of a project under CEQA and no environmental impacts are anticipated to occur.

County Counsel has approved resolution Number 2024-068 as to form.

Impact on Residents and Businesses

The vacation of Busby Road, Spiro Road, and portions of Ano Crest Road and Leon Road in the Winchester area, will not impact residents or businesses.

Additional Fiscal Information

All fees are paid by the applicant. There is no General Fund obligation.

Exempt Status: California Environmental Quality Act (CEQA) Guidelines, Section 15061(b)(3), General Rule "Common Sense" Exemption. Not a "project" as defined under State CEQA Guidelines, Section 15060(c).

Reasons Why Project is Exempt: The vacation of a street has been determined to not be a "project" as defined under State CEQA Guidelines section 15060(c). However, even if it was determined to be a project under CEQA for analysis purposes, the project is exempt from the provisions of CEQA specifically by the State CEQA Guidelines as identified below. The vacation of the existing roadway will not result in any specific or general exceptions to the use of the categorical exemption as detailed under State CEQA Guidelines Section 15300.2. The project will not cause any impacts to scenic resources, historic resources, or unique sensitive environments. Further, no unusual circumstances or potential cumulative impacts would occur that may reasonably create an environmental impact. The vacation of this street will not have an effect on the environment; thus, the County has deemed this does not meet the definition of a "project" under CEQA and no environmental impacts are anticipated to occur.

Section 15061(b)(3) - General Rule "Common Sense" Exemption. With certainty, there is
no possibility that the proposed project may have a significant effect on the
environment. Vacating a street will not require any construction activities, change the
use or intensity of the existing site to create a physical environmental impact, and would
not lead to any direct or reasonably foreseeable indirect physical environmental impacts.
Therefore, in no way would vacating a street have the potential to cause a significant
environmental impact and the vacation is exempt from further CEQA analysis.

Section 15060(c) – for purposes of analysis under CEQA, vacating a street is not a
 "project" under CEQA pursuant to Section 15060(c). An action by a public agency is
 only a "project" subject to CEQA if the action might result in a physical change in the
 environment. Based upon a review of the whole action undertaken, supported, or
 authorized by the County, in no way will vacating a street increase the use of the site,
 result in increased development or construction impacts, or lead to any direct, indirect,
 or cumulative physical environmental impacts.

Based upon the identified exemptions above, the County of Riverside hereby concludes that no physical environmental impacts are anticipated to occur and the project as proposed is exempt under CEQA. No further environmental analysis is warranted.
