# BACKGROUND:

#### Summary

California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct elections by submitting a resolution requesting these services. The Temecula Valley Unified School District has complied with this requirement and has requested the Registrar of Voters to conduct its election. The department has the resources to provide these services. The County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election.

#### Impact on Residents and Businesses

Registered voters in the Temecula Valley Unified School District will have the opportunity to vote on a special recall in Trustee Area 4.

# **Additional Fiscal Information**

The County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election. Approximately \$75,000 of election costs will be reimbursed by the Temecula Valley Unified School District.

#### Rationale

On January 22, 2024, at 10:55 a.m., the Registrar of Voters emailed the Temecula Valley Unified School District containing a certificate confirming the verification of signatures on the petition for the recall of Governing Board Member Dr. Joseph Komrosky. The email included the certificate.

The procedures for determining the sufficiency of a petition, as outlined in Elections Code sections 11224 and 11225, detail the steps to confirm if the required number of voters have signed. As per Section 11224, upon confirming the sufficiency of the petition, the Registrar of Voters is mandated to certify the examination results to the Board of Education during its next Regular Meeting.

According to Section 11240 of the Elections Code, the Board of Education is required to issue an order within 14 days after receiving the certificate of sufficiency of the recall petition during its regular meeting. This order declares the holding of an election to determine whether the named officer in the petition should be recalled. As stipulated in Elections Code section 11242, the recall election must take place not less than 88 days nor more than 125 days after the issuance of the election order. However, there is provision for the recall election to be conducted within 180 days to coincide with a regularly scheduled election. In the event that the Board of Education does not initiate the recall election, Elections Code section 11241 empowers the Registrar of Voters to call for the recall election.
