BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. **Bike Temecula Valley, Corp.** - \$5,000-The funds will be used to support the Ride the Vines Charity Ride Bike, an event that raises funds to promote cycling safety in the southwest region and tourism.
2. **Michelle's Place Cancer Resource Center** -\$25,000-The funds will be used to support Michelle's Place Behavioral Health program. This program provides 150 cancer patients and their families with behavioral health counseling sessions. Each patient will receive 10 sessions and 5 family/children support sessions.
3. **Hospice of the Valleys SC** -\$3,500- The funds will be used to support the Senior Assistance program, a program that pays the cost of hospice care for seniors and severely disabled individuals.
4. **NAMI (National Alliance on Mental Illness) Temecula Valley**-\$5,000-The funds will be used to support the Mind and Body Wellness Experience, an event that promotes mental health awareness and offers support services.
5. **Favors for Neighbors**-\$5,000- The funding will be used to provide seniors with minor home repairs, transportation to medical visits, and meal deliveries.
6. **The Salvation Army, A California Corporation**-\$10,000-The funding will be used to support the Child Spree program, an event that provides 250 children with back-to-school supplies and clothing.
7. **MilVet**-\$10,000-The funding will be used to provide veterans with emergency food boxes, diapers, and household items.
8. **St. Martha's Food Pantry DBA Community Food Pantry**-\$10,000- The funding will be used to provide pantry staples to low-income families in the Murrieta, Winchester, and French Valley areas.
9. **Animal Town Sanctuary**-\$1,000- The funding will be used to provide senior dogs with vet care.
10. **Cultivating Inclusion Inc.**-\$5,000- The funding will be used to increase food safety awareness and to support the Cultivating Inclusion Farm program, a program that teaches special needs individuals, and local high school students about farming.

11. **Riverside County Department of Animal Services**-\$27,000-The funding will be used to purchase 9 mobile spay/neuter clinics for the third district residents.

12. **Riverside County Works, C/O Jamil Dada Character Excellence Youth Awards**-\$2,500-The funding will be used to support the Jamil Dada Character of Excellence Youth Awards Ceremony, an event that honors and awards at-risk youth ages 16 to 24 with academic scholarships.

13. **Temecula Valley Chamber of Commerce**- \$3,800- The funding will be used to support two different programs (1) the Temecula State of the City address, an event that brings civic leaders, residents, and business together to celebrate the accomplishments and future of the City of Temecula and (2) the Southwest Regional Economic Forecast, an educational event where attendees will hear from economic expert Dr. Chris Thornburg about the current and future state of the economy.
