BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. The Civil Rights Institute of Inland Southern California (CRIISC) serves as a home for civil rights education and engagement. One of their goals is to further establish relationships with the desert and mountain regions to further outreach their efforts and document wider histories. CRIISC established an exhibition *Working Coachella: Images of the Farmworker Community in the Coachella Valley* in Downtown Riverside. It is now moved to the City of Coachella from May through August 2024. The exhibition includes 52 photographs with text and excerpts of interviews with those in the pictures, showcasing the culture and labor of the indigenous workers who produce the food we eat. CID funds will support the Coachella exhibition.
- 2. Hocker Productions hosted the inaugural Cinco De Mayo event in Palm Springs on Sunday, May 5th. This event brought authentic Mexican cuisine, art, and music into Downtown Palm Springs. Funds raised at this event will be used to support the Palm Springs Sister City program with San Miguel, Mexico to assist with the children's art programs and sports equipment. CID funds will be used toward the Sister City Program.
- 3. Olive Crest provides services in child abuse prevention by strengthening, equipping, and restoring children and families in crisis. Family Preservation In-Home "Wraparound" services provide mental health and behavior-based support to children and parents to strengthen clinical treatment plans. Support is preventative with the goal of providing intervention that allow youth to remain in their home rater than being placed in the foster care system. CID funds will be utilized to support efforts for informal support and after-care to ensure lasting improvement in wraparound families.
- 4. The Regional Access Project (RAP) Foundation serves as the fiscal agent for the scholarship fund for the Fourth District Youth Advisory Council (YAC). YAC members are high school students who participate in monthly community and county service projects in the Fourth District. Students who have served in Fourth District YAC receive a scholarship to help their future academic needs. CID funds will go to the RAP foundation to support the scholarship fund.
