SUBJECT: SHERIFF-CORONER-PA: Approve Transfer of Unclaimed Money to County General Fund; All Districts [\$62,672 – 65916 - Sheriff's Unclaimed Funds]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the transfer of unclaimed money in the amount of \$149,163.68 from the Sheriff's Office Unclaimed Fund 65916 to the County General Fund (10000-2500200000-781140), as permitted by California Government Code Sections 50053 and 50055, including \$140,268.72, which was previously advertised but remains unclaimed, and \$8,894.96 in unclaimed amounts that were not subject to the newspaper publication (amounts under \$15 or those with unknown source of deposit); and
2. Authorize the transfer of \$62,672 in unclaimed money from Fund 65916 to the Sheriff's Office budget (Fund 10000-2500200000-781260) for reimbursement of costs incurred in the process.



BACKGROUND:

Summary

California law requires that the Sheriff's Office periodically publish a notice listing unclaimed money (amount over \$15), which are held in the Sheriff's Office's custody for more than three years, before the unclaimed money becomes the property of the County. As set forth in Section 50050 et. seq. of the California Government Code, the Sheriff's Office completed the required newspaper publication in the California Newspaper Partnership (Press Enterprise), Desert Sun, and Palo Verde Valley Times. The appropriate time was given for parties of interest to file claims prior to the filing deadline.

As required by California Government Code 50050, section (a):

50050. (a) For purposes of this article, "local agency" includes all districts. Except as otherwise provided by law, money, excluding restitution to victims, that is not the property of a local agency that remains unclaimed in its treasury or in the official custody of its officers for three years is the property of the local agency after notice if not claimed or if no verified complaint is filed and served. At any time after the expiration of the three-year period, the treasurer of the local agency may cause a notice to be published once a week for two successive weeks in a newspaper of general circulation published in the local agency. At the expiration of the three-year period, money representing restitution collected on behalf of victims shall be deposited into the Restitution Fund or used by the local agency for purposes of victim services. If a local agency elects to use the money for purposes of victim services, the local agency shall first document that it has made a reasonable effort to locate and notify the victim to whom the restitution is owed. With respect to moneys deposited with the county treasurer pursuant to Section 7663 of the Probate Code, this three-year period to claim money held by a local agency is extended for an infant or person of unsound mind until one year from the date their disability ceases.

In the process, the Sheriff's Office has incurred costs of \$62,672 for the County Counsel legal services and the newspaper publications.

Per California Government Code Section 50055, individual items less than fifteen dollars or any amount if the depositor's name is unknown does not require a newspaper publication in order to be transferred to the general fund, as stated below:

50055. Any other provision of this article notwithstanding, any individual items of less than fifteen dollars (\$15), or any amount if the depositor's name is unknown, which remain unclaimed in the treasury or in the official custody of an officer of a local agency for the period of one year or upon an order of the court may be transferred to the general fund by the legislative body without the necessity of publication of a notice in a newspaper.

Impact on Residents and Businesses

Funds subject to newspaper publication have been held available for reimbursement for over three years, and with all efforts made to contact and reimburse these funds with no response, the impact is minimal.
