

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Riverside County Works c/o Jamil Dada Character Excellence Youth Awards Ceremony - \$2,500** will be allocated to support Riverside County Workforce Investment Board's scholarship Program at the Annual Character Counts Youth Awards Ceremony.
2. **Riverside Meals on Wheels, Inc. - \$5,000** will be used to assist with meals for homebound seniors in the First District.
3. **The Grove Community Church - \$35,000** will be used to purchase and install security cameras at the Moses Schaffer Community Center in Good Hope.
4. **Riverside County Sheriff's Department - \$2,500** will be used to support their employee and community volunteer recognition ceremony.
5. **Evergreen Memorial Historic Cemetery - \$2,000** will be used to supplies, marketing, equipment and permits, for their Founders' Day event.
6. **Riverside Art Museum- \$2,500** funding will be used to support the ticket cost for students and seniors to visit the Riverside Arts Museum.
