- 2. Authorize the EMD Director, or designee, to sign amendments to the agreements that stay within the intent and maximum term of the agreement, including to allow a city to change between the options set forth in Exhibit B of the original Agreement, as approved-as-to-form by County Counsel; and
- 3. Approve the EMD Assistance by Hire (ABH) rates, attached hereto, for maximum hourly rate, overtime rate, and administrative costs, which will cover any overtime or extraordinary costs: (1) outside of the established rates set forth in Exhibit B (Payment Provisions) of the Agreement, and (2) for the invoicing of non-contract entities for services requested from EMD; and

BACKGROUND:

Summary

On July 7, 2021, Item 3.10, the Board of Supervisors (Board) approved the Emergency Management Department (EMD) Partnership Agreement that allows the Emergency Management Department to offer direct Emergency Management Services to partners. The Partnership Agreement evaluates the need for a successful Emergency Management (EM) Program that includes all four phases of Emergency Management. The EM Services include but are not limited to four phases in Emergency Management: mitigation, preparedness, response and recovery.

There are four agreement options offered:

The options listed above allow each city to create their ideal level of service while enabling the county to achieve a full cost recovery for services as they are provided.

The actions before the Board extend the agreements for one year through June 30, 2025 and include delegating authority to the EMD Director or his or her designee to execute amendments, consistent with the attached template amendment, and to execute additional amendments, to the extent an election is made to change service options during the term of the agreement, as approved-as-to-form by County Counsel. The attached template has been approved as to form by County Counsel.

The Auditor-Controller's Office (ACO) reviewed the extension of the proposed rates and determined that the rates recover the full cost of services provided. EMD will bring back to the BOS the next 3-year agreement proposal and will include a full cost recovery rate analysis to reflect the anticipated salary increases. The analysis will be reviewed by the ACO to ensure the following: 1) a reasonable methodology has been adopted to calculate

the rate for services, and 2) the cost used to calculate the rates are an actual reflection of the full cost on an ongoing basis.

Impact on Residents and Businesses

Emergency services personnel will enhance the preparedness and response capabilities in case of an emergency or natural disaster.

Additional Fiscal Information

The Agreement does not cover any extraordinary costs, such as overtime. Assistance by Hire (ABH) rates attached hereto set forth the maximum hourly rate, overtime rate, and administrative costs, and they are in line with the current County of Riverside cost allocation plan. Approval of these rates will ensure the coverage of any overtime or extraordinary costs outside of the established rates set forth in Exhibit B (Payment Provisions) of the Agreement and the rates for invoicing non-contract entities for services requested from EMD.

AMENDMENT NO. X TO THE AGREEMENT FOR EMERGENCY SERVICES COORDINATOR SERVICES BETWEEN THE COUNTY OF RIVERSIDE

This First Amendment to the Agreement (the "Amendment") is entered into by and between the County of Riverside ("County") and the City of ("City").

RECITALS

WHEREAS, COUNTY and CITY entered into the Agreement for Emergency Services Coordinator (ESC) Services, effective through June 30, 2024; and

WHEREAS, COUNTY now desires to renew the Agreement for an additional one-year term through June 30, 2025;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, COUNTY and CITY agree as follow:

- 1. The above recitals are true and correct and are incorporated herein by reference.
- 2. Section 1.2 of Exhibit B, Payment Provisions, shall be deleted in its entirety and replaced with the following:
 - "1.2 The compensation payable to County for all services as set forth in this Agreement for the period commencing on or after July 1, 2022, and running through June 30, 2024, is XX dollars (\$)."
- 3. All other terms and conditions of the Agreement not modified herein shall remain unchanged and in effect. If any provisions of this Amendment or the Agreement shall be determined to be illegal or unenforceable, such determination shall not affect any other provision of the Agreement and all such other provisions shall remain in full force and effect. The language in all parts of the Agreement shall be construed according to its normal and usual meaning and not strictly for or against either party.
