BACKGROUND:

Summary

Pursuant to Government Code Section 25365, the County of Riverside (County) may, after notice and by a vote of not less than four-fifths, transfer real property or any interest therein, belonging to the County to another public agency, upon the terms and conditions as are agreed upon if the property or interest therein to be conveyed is not required for county use. Through this action, the County seeks to convey fee simple Interest in real property located in the Community of Mecca, County Assessor's Parcel Number 727-184-034, 727-184-035, 727-184-036 by Grant Deed to the Riverside County Board of Education.

The combined Property is an approximately .33 acre vacant site which was recently appraised by an independent appraiser at a fair market value of one hundred forty-one thousand dollars (\$141,000) and Riverside County Board of Education (RCOE) has agreed to pay this fair market value to the County to purchase the Property. RCOE plans to combine this small Property with a contiguous property that it is purchasing from the Successor Agency to develop a Childcare Administrative Center.

Facilities Management (FM) recommends that the Property be declared exempt surplus land because it will be conveyed to another local agency for the transferee agency's use and no longer needs to be owned in fee for the County or public purpose, per Government Code Section 54221(f)(1)(D). Housing and Community Development has been advised of this declaration of exempt surplus.

Therefore, FM recommends the adoption of Resolution No. 2024-086 to declare the Property exempt surplus and provide County's notice of intent to convey the Property.

Resolution No. 2024-086 has been reviewed and approved by County Counsel as to legal form.

Impact on Citizens and Businesses

The sale of this Property will assist RCOE in its efforts to provide childcare services to the citizens of this region of the County.

Declaration of Exempt Surplus Land and Notice of Intention to Convey

Fee Simple Interest in Real Property Located in the community of Mecca,

County of Riverside, California, Assessor Parcel

Numbers 727-184-034, 727-184-035, 727-184-036 by Grant Deed to the

Riverside County Board of Education

WHEREAS, the County of Riverside ("County") is the owner of certain unimproved real property in the community of Mecca, County of Riverside, State of California, identified as Assessor Parcel Numbers (APN) 727-184-034, 727-184-035, 727-184-036 (the "Property"); and

WHEREAS, the County deems the Property as no longer required, nor will it be required in the future, for County uses or purposes; and

WHEREAS, because the Property is no longer required for any County purpose, it is hereby deemed exempt surplus land under the Surplus Land Act (SLA) pursuant to California Government Code Section 54221(f)(1)(D) because the Property is being transferred to another governmental agency for the transferee agency's use; and

WHEREAS, the County desires to transfer the Property to the Riverside County Board of Education, a board of education organized and existing pursuant to the laws of the State of California; and

WHEREAS, Riverside County Board of Education and the County concur that it would be in both parties' best interest to transfer ownership of the Property to the Riverside County Board of Education; and

WHEREAS, pursuant to Government Code Section 25365, the Board of Supervisors may, by a vote of not less than four-fifths, transfer or sell real property or any interest therein, belonging to the County to another public agency, upon the terms

 and conditions as are agreed upon and without complying with any other provisions of Government Code, if the property or interest therein to be conveyed is not required for County use; and

WHEREAS, the County has reviewed and determined the declaration of surplus and notice of intent to sell County owned real property interests as categorically exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines sections 15312 and 15061(b)(3) because the proposed project is the sale of real property involving the transfer of title to real property that is no longer needed for the use by or purposes of the County, does not have significant values for wildlife habitat or other environmental purposes, the use of the Property and adjacent property has not changed since the time of acquisition by the County, and it can be seen with certainty that the project will not have a significant effect on the environment because it is merely the transfer of title to real property of vacant land and does not involve construction activities or an increase in the intensity of use of the site; now, therefore.

BE IT RESOLVED, DETERMINED AND ORDERED and **NOTICE IS HEREBY GIVEN** by the Board of Supervisors of the County of Riverside, California, in regular session assembled on April 30, 2024, that the County of Riverside declares the Property exempt surplus land pursuant to California Government Code Section 54221(f)(1)(D) because the Property is being transferred to another local agency for the transferee agency's use, and the County intends to convey to the Riverside County Board of Education, on or after June 4, 2024, the Property by Grant Deed as more particularly described in Exhibit "A" attached hereto and made a part hereof.

BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the Board has evaluated and determined that the Property intended to be conveyed to the Riverside County Board of Education is no longer necessary to be retained for the County's uses and purposes.

BE IT FURTHER RESOLVED, DETERMINED AND ORDERED, pursuant to the Surplus Land Act Guidelines, Article IV, Section 400(e), the Director of Facilities Management, or designee is hereby directed to provide a written copy of this resolution declaring the Property exempt surplus land to the California Department of Housing and Community Development at least 30 days prior to County's disposition of the Property;

BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the Clerk of the Board of Supervisors is directed to give notice hereof as provided in Section 6061 of the Government Code.
