BACKGROUND:

Summary

On November 8, 2022, Item 3.10, the Board of Supervisors (Board) approved the emergency Construction Contract between the County of Riverside (County) and Belfor in the amount of \$4,000,000 for the declared emergency RUHS-MC 2nd Floor Water Remediation Project, located at 26520 Cactus Avenue in Moreno Valley, California, 92555. The scope of the Project included but was not limited to: removal and replacement of dry wall, flooring, insulation and tile in various office and corridors within the lower level, first and second floors.

Belfor has completed the work satisfactorily, and the Project has been inspected and found to comply with contract and safety requirements. This Board action will release the undisputed contract retention funds in the amount of \$200,000 to Belfor, after the Notice of Completion has been recorded and the 35-day lien period has expired per contract terms and applicable law.

Impact on Residents and Businesses

The RUHS-MC 2nd Floor Water Remediation Project will provide a safe environment for both hospital staff and patients.

Additional Fiscal Information

All costs associated with this Board action were previously approved on November 8, 2022 (Item 3.10) and are 100% funded with RUHS Enterprise Fund 40050. The retention amount of \$200,000 is accounted for within the approved budget and will be expended in FY 23/24, therefore no budget adjustment is required.


