

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to the Riverside County Sheriff's Department (\$2,500.00) will be used to support members of its sworn, and non-sworn staff, volunteers, and members of the community for service to their fellow citizens and community members.
2. The donation to the Lake Norconian Club Foundation (\$5,000.00) will be used to continue to protect and preserve the former Norconian historic Navy Installation and support both veterans and their families through the annual Pearl Harbor Remembrance Ceremony.
3. The donation to the Corona Lions Club (\$1,500.00) will be used to support high school student scholarships to continue in their educational journey to colleges and universities.
4. The donation to Eastvale Kiwanis, Inc. (\$5,000.00) will be used to support the Ike Bootsma Kiwanis Memorial Scholarship, Dual Immersion Mandarin Program, and the Today a Reader, Tomorrow a Leader school program to assist with books for elementary school students.
5. The donation to the Corona History Association (\$5,000.00) will be used to support the annual tribute to the founding of Corona and contribute to the preservation and education of the community.
