BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

 Soroptimist House of Hope (SHOH) is addressing the urgent health and social services crisis through our transformative substance use disorders and mental healthcare program at their residential treatment home in Desert Hot Springs.

Their programs serve low-income women ages 18 and over who are seeking self-sufficiency and avoid homelessness. services to approximately 40+ women annually. The program's desired outcomes are that program participants will overcome their addictions, maintain long-term sobriety, improve their physical and mental health through continued access to ongoing medical care through MediCal, be reunited with their families and children, achieve self-sufficiency, and lead healthy, productive, and substance-free lives.

The Soroptimist House of Hope is residential home with limited space. Staff uses a den as office space. To address the issue, the garage would be modified to support two offices as well as quiet spaces for counseling sessions with privacy. CID funds will assist with cost of converting the garage into an office space.

2. ABC Recovery provides care to several of the most underserved and vulnerable segments in our communities: those in poverty or the lower-socioeconomic threshold-the majority of which are an ethnic minority, those who are justice involved, those who are undocumented, those in the LGBTQIA community, and those with mental health issues and in need of treatment for a substance-use disorder.

The recovery housing village is a 40-bed village that is on average 98% at capacity year-round. All of those housed in the village are homeless or at risk of becoming homeless and have completed inpatient treatment. The village allows participants to reintegrate back into society after treatment and sometimes long-term incarceration.

ABC is in need of replacing the air conditioning system within their administration building. As well as replacing all walkways in the Recovery Housing village due to safety hazards. CID funds will assist with the cost of replacing two AC Units and to replace pavers with concrete and xeriscaping.
