BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The Summer Brain Gain program offered at the Boys and Girls Club of Coachella Valley offers an enjoyable and engaging summer learning opportunity for young people, while also helping to narrow the academic achievement gap in the region. The program follows a project-based learning approach, where young learners discover, express creatively, work in groups, design & build STEM kits, participate in interactive learning opportunities (zoo, fishing, sporting events, and more) and complete final projects or productions. CID funds will be used to help cover the expenses related to the program at all four clubs; Coachella, Indio, Mecca and La Quinta.
2. Chance Initiatives looks to further helping youth offenders by offering In-Institution life coaching and mentorship to juveniles both at Indio Juvenile Hall and at the Alan M. Crogran Youth Treatment and Education Center (YTEC). Youth offenders who are released from incarceration are sometimes left to fend for themselves, the Initiative wants to meet the needs of young adults coming home from incarceration by giving individuals the chance to succeed with dignity and value. CID funds will help cover the cost of on driver license fees, new clothes, shoes, hygiene and transportation to and from established programs.

3. College of the Desert established the Gender and Sexual Diversity Pride Center (GSD Pride Center) in 2021. The Center serves as a space for educational programming, counseling sessions, workshops, activities, events, and collaboration that unite LGBTQIA+ campus community, allies, and local community. The Center seeks to support student participation in various events throughout the Coachella Valley to build self, community awareness and promote secondary education opportunities. CID funds will be used for students and the financial needs of their participation in regional events and conferences.
4. The Riverside County Sheriff's Office will hold their annual awards ceremony on June 26th, at Pechanga Resort & Casino. The ceremony recognizes members of its sworn and non-sworn staff, volunteers as well as, members of the community for service and actions towards their fellow citizens. The recipients receive medals, plaques, and other significant recognition awards. CID funds will assist to cover expenses of this event.
5. The Jamil Dada Character Excellence Youth Awards is an existing program that has supported youth for the last 16 years. Each year, students from each supervisorial district receive recognition for their academic achievements as well as exemplary character traits. The awards ceremony will take place on July 12, 2024, at the March Field Air Museum. CID funds will be used for scholarships.
6. Spay Neuter Imperative Project California also known as SNIP Bus provides low-cost mobile spay/neuter and vaccinations clinics to end animal overpopulation and lessen burden on local shelters. CID funds will be used to hold clinics throughout the 4th District.
7. Voices for Children (VFC) transforms the lives of abused, abandoned, or neglected children by providing them with trained, volunteer Court Appointed Special Advocates (CASAs). CID funds will be used to support advocacy supervisors who carry a caseload of 35-45 CASA volunteers.
