BACKGROUND:

Summary

On April 13, 2021 (Agenda Item 12.1), the Board awarded Tetra Tech BAS, Inc., a three-year contract for Construction of Landfill Gas Collection System (GCS) Components at the Badlands, Corona, Lamb Canyon, and Mecca II Sanitary Landfills and as needed Perimeter Probe Installation at all Department Landfills.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Lamb Canyon Landfill GCS Expansion Phase 3 project at a cost of \$85,158.19 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated March 1, 2023, at the Lamb Canyon Landfill.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Corona Landfill GCS HDPE Conversion project at a cost of \$108,383.20 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated March 1, 2023, at the Corona Landfill.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Highgrove Landfill Perimeter Gas Probe System Expansion project at a cost of \$38,468.50 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated August 8, 2023, at the Highgrove Landfill.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Badlands Landfill GCS Expansion Phase 5 project at a cost of \$115,460.25 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated August 9, 2023, at the Badlands Landfill.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Lamb Canyon Landfill GCS Header Repair project at a cost of \$5,758.03 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated August 30, 2023, at the Lamb Canyon Landfill.

Tetra Tech BAS, Inc. satisfactorily completed construction of the Badlands Landfill Flare #3 Header project at a cost of \$79,459.04 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated November 28, 2023, at the Badlands Landfill.


