#### **BACKGROUND:**

#### **Summary**

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the June 4, 2024, Temecula Valley Unified School District, Trustee Area 4, Special Recall Election has been completed and certified by the Registrar of Voters. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On May 21, 2024, the Board of Supervisors approved the conduct of election services for the Temecula Valley Unified School District, Trustee Area 4, Special Recall Election. Election costs fully reimbursable from the jurisdictions are approximately \$75,000.

The election was successfully held on June 4, 2024 with 45.06% turnout. Staff recommends that the Board receive and file the certified statement of the results of the election for this Temecula Valley Unified School District, Trustee Area 4, Special Recall Election.

#### Impact on Residents and Businesses

Registered voters in the Temecula Valley Unified School District had the opportunity to vote on a special recall in Trustee Area 4.

#### **Additional Fiscal Information**

As approved by the Board of Supervisors on May 21, 2024, the County will receive reimbursements from the jurisdiction for the full costs of conducting their election. Approximately \$75,000 of election costs will be reimbursed by the jurisdiction.
