BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Chance Initiatives looks to further helping youth offenders by offering In-Institution life coaching and mentorship to juveniles both at Indio Juvenile Hall and at the Alan M. Crogran Youth Treatment and Education Center (YTEC). Youth offenders who are released from incarceration are sometimes left to fend for themselves, the Initiative wants to meet the needs of young adults coming home from incarceration by giving individuals the chance to succeed with dignity and value. CID funds will help cover the cost of on driver license fees, new clothes, shoes, hygiene, and transportation to and from established programs.
- 2. Culturas Music-Arts will host the Coachella's Synergy Music & Arts Festival on November 9. Synergy brings talented artist and its diverse street culture to life. The festival is a free event to the public and includes a car show, music of all genres, art displays, small local independent vendors and "Color Me Kids" area, which offers children to play in a safe environment with free interactive games, crafts, and books to encourage reading. CID funds will be utilized to provide a stipend for the artist.
- 3. Dr. Carreon Foundation (DCF) was started in 1991 by Reynaldo J Carreon MD, a Coachella Valley philanthropist who had a passion for helping Mexican American youth with education opportunities. The board of DCF expanded the mission to include assistance for other minority ethnicities. Throughout the years over 1000 students have received over \$2 million for assistance with post high school education. CID funds will be used for scholarships to students pursuing higher education.
- 4. The Regional Access Project (RAP) Foundation serves as the fiscal agent for the scholarship fund for the Fourth District Youth Advisory Council (YAC). YAC members are high school students who participate in monthly community and county service projects in the Fourth District. Students who have served in Fourth District YAC receive a scholarship to help their future academic needs. CID funds will go to the RAP foundation to support the scholarship fund.
- 5. Raices Cultura promotes the preservation of cultural traditions and the development of personal voice, creativity, and civic engagement through the arts all in service of transformational justice. The Dia de Los Muertos community celebration honors the ancient indigenous traditions of Mesoamerican peoples combined with Mexican and Spanish cultural influences that celebrates the lives of loved ones who are no longer within the living world. CID funds will be used to help cover the cost of art workshop & activities for this event.
