BACKGROUND:

Summary

The District's Board approved a contract with the Contractor in the amount of \$4,254,444 as Agenda Item Number 11.3 (MT 21534) on April 18, 2023.

During construction the Contractor exposed an existing subdrain system that was discovered to contain asbestos, which required additional means and methods for the Contractor to safely remove and legally dispose of. The extra work from this Change Order No. 1 was in the amount of \$330,000.

During the construction of the remainder of the project, some savings were realized in other contract items, such that the net effect on the total contract is only an increase of \$288,526.

Final inspection of the Project was made, and the Project was found to be complete according to the plans and specifications. A brief Project description and location map is attached. The final price for the contract is \$4,542,970, which is within 7% of the contract amount.

The District does not anticipate any claims for additional compensation from the Contractor.

Impact on Residents and Businesses

The Project replaces approximately 2,300 feet of existing concrete trapezoidal channel with higher capacity reinforced concrete box and concrete rectangular channel. The primary objective is to provide 100-year flow capacity within the proposed facility and remove the existing Federal Emergency Management Agency floodplain, resulting in positive impacts to residents and businesses.

Contract History and Price Reasonableness

Pursuant to Public Contract Code 21091, invitation of sealed bids was solicited by advertising in print and digital media.

The final price for the contract is \$4,542,970.28, which is approximately 7% over the original contract amount. The added costs due to Change Order No. 1 were negotiated with the Contractor in accordance with Section 2.07 of the contract General Provisions.

CONTRACT CHANGE ORDER NO. 1

To <u>Mamco</u>, <u>Inc. dba Alabassi</u>, Contractor you are hereby directed to make the herein described changes from the plans and specifications or to do the following described work not included in the plans and specifications.

Description of work to be done, estimate of quantities, and prices to be paid. Unless otherwise stated, rates for rental of equipment cover only such time as equipment is actually used and no allowance will be made for idle time. Change requested by District.

El Cerrito Channel Restoration, Stage 90 (Project) replaces 2,300 feet of existing trapezoidal channel with a higher capacity reinforced concrete box and concrete rectangular channel to provide 100-year flow capacity. Project collects flows from existing storm drain systems at the El Cerrito Road – Temescal Canyon Road/Ontario Avenue intersection and conveys them northeasterly to Temescal Creek.

Mamco, Inc. dba Alabassi (Contractor), began demolition and removal of the existing concrete channel on August 25, 2023. During this operation they encountered a subdrain running below the channel that the Contractor believed was a limited asbestos-containing material (ACM). The Riverside County Flood Control and Water Conservation District (District) retained the services of Kleinfelder on August 31, 2023 to perform a limited ACM survey and evaluate the presence, location and quantity of suspected asbestos-cement subdrain piping. Based on the review of the laboratory analytical report, the ACM sample contains 25% chrysotile asbestos.

Regulatory oversight for the management, removal, and disposal of ACMs is provided by a variety of federal, state and local agencies. The US EPA regulations concerning the identification, handling, management, and abatement of ACMs are implemented locally by South Coast Air Quality Management District (SCAQMD). Both the US EPA and SCAQMD define ACM as material containing greater than 1 percent asbestos.

Project No.: 2-0-00110-90

Contractor proposes to perform the extra work of removing and legally disposing of all asbestos containing subdrain pipe and appurtenances while following all applicable rules and regulations in accordance with SCAQMD, Cal/Osha, EPA and DTSC. All required permits for asbestos removal and disposal will be obtained by the Contractor and complied with. Contractor is requesting additional compensation for the above-described work, as well as for the associated slowdown of their planned operation. The Contractor has provided a detailed estimate and breakdown for the extra work, see Exhibit A.

The District has concluded that the presence of asbestos-containing subdrain pipe constitutes a change of conditions and finds the proposal of \$330,000 to be fair and acceptable. This Change Order covers all costs incurred due to the slowdown of construction and all costs relating to the complete removal and legal disposal of the asbestos-containing subdrain / appurtenances; including incidental expenses including but not limited to additional equipment, man hours, standby time, and disposal costs.

Payment will be made as a lump sum when a Notice of Completion has been issued.


