- 2. Approve the plans and specifications for the construction of the Good Hope Area Sidewalk Improvements Project in the Community of Good Hope;
- Authorize the Clerk of the Board to advertise for bids to be received by the office of the Director of Transportation and Land Management at the Transportation Annex located at 3525 14th Street, Riverside, CA 92501. All bids must be received up to the hour of 2:00 p.m., Wednesday, July 31, 2024 at which time bids will be opened, and
- 4. Direct the Clerk of the Board of Supervisors to file the Notice of Exemption with the County Clerk and the State Clearinghouse for posting within five (5) working days.

### BACKGROUND:

### Summary

The Transportation Improvement Program (TIP) provides for the construction of the Good Hope Area Sidewalk Improvements Project in the Community of Good Hope of Riverside County.

Mainly, the proposed project will construct new concrete sidewalk and curb and gutter on the south side of Steele Peak Drive along a 750-feet segment between Main Street and Palm Street, on the east side of Palm Street along an 800-feet segment between Steele Peak Drive and Mountain Avenue, and on the north side of Mountain Avenue along an approximately 2,000-feet segment between Palm Street and Theda Street.

Steele Peak Drive, Palm Street, and Mountain Avenue combined are one of the major pedestrian routes for Good Hope Elementary School and Moses Schaffer Community Center. The parkway areas on these roads currently contain obstructions to pedestrian use, such as fences, trees, and random landscape and hardscape. This project proposes to construct approximately 3,550 linear feet of new sidewalk and new curb ramps, providing a safer pedestrian path for students and community residents.

The project also includes resurfacing the existing asphalt concrete pavement. The resurfacing treatment consists of removing the existing asphalt concrete pavement and underlying material and placing back new hot mix asphalt pavement.

Additional improvements include construction of concrete curb ramps, cross gutter, driveways, and asphalt concrete dike. Safety features include placing of roadside signs, traffic stripes, and thermoplastic crosswalks and pavement markings.

The proposed improvements will provide a fully American with Disabilities Act (ADA) accessible all-weather pathway for pedestrians.

On March 11, 2021, President Biden signed the \$1.9 trillion American Rescue Plan Act (ARPA) of 2021 into law. To accelerate recovery from the economic and health impacts of the COVID-

19 pandemic, the County of Riverside was provided approximately \$480 million. The Executive Office in conjunction with the Board Supervisors developed a plan to disburse these funds based on the principles of providing recovery funding to those sectors of our economy and society that are struggling most to recover from the pandemic; have a constituent and community based focus; provide a vehicle for transformational investment in our County's recovery from COVID-19; provide for countywide equity; and focus on one time investments, rather than funding ongoing operational costs. As a result of these principles, the Good Hope Area Sidewalk Improvements Project was selected as a recipient of \$2,300,000 of ARPA funds from District 1 per Minute Order dated December 13, 2022 (Agenda Item 3.2).

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedules of work:

Base Bid Schedule: Good Hope Area Sidewalk Improvements Project and associated work Alternative Bid Schedule 1: Eastern Municipal Water District (EMWD) facilities relocation

The relocation of the facilities owned by EMWD is also included in the bid package as an alternative bid schedule. If EMWD approves the award of their alternative bid schedule, as bid by the apparent low bidder, then the cost for the work will be funded by the utility owner through a reimbursement letter Agreement that will be executed by the Director of Transportation. The Director of Transportation has the authority to sign reimbursement Agreements up to \$100,000 per Minute Order dated November 19, 2019 (Agenda Item 3.25).

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid for the sum of all bid schedules.

### Environmental Findings

The proposed project is exempt from CEQA under Section 15301 (c) – Existing Facilities exemption because the Good Hope Area Sidewalk Improvements Project does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadway and associated facilities.

### Impact on Citizens and Businesses

The proposed improvements will improve pedestrian safety and provide an Americans with Disabilities Act (ADA) compliant path. The new sidewalk will serve as a path to and from Moses Schaffer Community Center located on Steele Peak Drive.

The work is scheduled to begin in December 2024. The work will be phased to keep the road open during construction as much as possible and will take approximately three months to complete.

**PROJECT DESCRIPTION:** The County of Riverside Transportation Department is proposing to construct approximately 2000 feet of new sidewalk, curb and gutter along the north side of Mountain Ave from Theda St to Palm St; 800 feet of new sidewalk curb and gutter along east side of Palm St from Mountain Ave to Steele Peak Dr; and 750 feet of sidewalk curb and gutter along south side of Steele Peak Dr. These improvements will extend the limit of the proposed sidewalk from Good Hope Elementary and will provide a pedestrian path to the Moses Schaffer Community Center. Mountain Ave is a two-lane road with existing width varying from 24 feet to 30 feet and is classified as Secondary Road in the County of Riverside's General Plan. Palm St is a two-lane road with existing width varying from 24 feet to 26 feet and is classified as a Local Road in the County of Riverside General Plan. In addition to new sidewalk, curb and gutter construction, the proposed improvements will also widen a portion of roadway and resurface the remaining portion of existing pavement to accommodate and resurface parking along Moses Schaffer Community Center.

The proposed project will also include:

- Reconstruction of AC Dike
- Construction of PCC Cross Gutters and Spandrels, Curb & Gutter, Curb Ramps and Driveways
- Construction of Asphalt Concrete Driveways
- Minor Slope Re-Grading
- Utility Relocation
- Extension of existing Culverts
- Construction of under sidewalk drains
- Relocation of private fencing, walls, mailboxes
- Utility water valve cover and sewer manhole adjustments
- Partial striping and pavement markers
- Salvage/removal of existing signs and installation of new signs

#### **ENVIRONMENTAL ANALYSIS:**

The proposed project will not acquire additional right-of-way. A Permit to Enter and Construct will be required to construct the proposed driveway improvements.

This project is subject to compliance with the Western Riverside County MSHCP. In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside/inside of cell criteria area/conservation areas. This project is considered to be operation and maintenance; therefore, it is a covered activity under the Western Riverside County MSHCP.


If tree and/or vegetation removal takes place during the migratory bird breeding season (February 1 -September 1), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act.


The County of Riverside Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEOA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to construct approximately 2000 feet of new sidewalk, curb and gutter along the north side of Mountain Ave from Theda St to Palm St, 800 feet of new sidewalk, curb and gutter along east side of Palm St from Mountain Ave to Steele Peak Dr, and 750 feet of sidewalk, curb and gutter along south side of Steele Peak Dr. The project in its entirety is consistent with Section 15301(c) because it does not create additional traffic lanes and involves no expansion of use of the existing roadway and associated facilities.




