# Address to the Riverside County Board of Supervisor's Meeting 07/09/2024 9:30 am



I am here to speak to you and express my formal complaint against the Riverside County Department of Animal Services. They killed a dog I wanted to adopt, causing me emotional distress.

I went to the San Jacinto shelter on 05/24/2024 to adopt 2 dogs: A1798653 (female, named Penelope) and A1798395 (Male, named Duke). Savannah stated that I couldn't put an interest on the dogs until their stray hold was up and they were available on their website. I now know that this particular policy ultimately caused Penelope's death.

I came back on the 29th and the 30th to adopt Penelope. The shelter worker lied to me and said that she went to another facility. I said, Why did you she go to another facility? You knew that I wanted to adopt her. I asked them for her whereabouts so I could go adopt her. Another staff member took over, and stated that they couldn't give out that information. The people standing behind me asked the staff if they had euthanized Penelope. I broke down crying and stated that I've been trying to adopt these 2 dogs since last week. I again asked where the female went and asked if they euthanized her. She said yes, because she tried to bite someone and they felt like she was a danger to the public.

Public records indicate that Penelope was adoptable and fearful. Maria Vogel reached out to me to try to do damage control. After receiving the public record, it became apparent that Maria misrepresented herself and omitted information. She signed off on Penelope's death. The notes state that there was no adoption interest, which is a lie. During her stray hold, she was not viewable to the public nor was she posted on their website for adoption. So how can Maria say that there was no adoption interest when she never put Penelope up for adoption?

The public record does not have any documentation of Penelope trying to bite anyone, yet this is the reasoning the staff gave me for her death. Nowhere does it state that I tried to adopt her on May 24th, 29th and the 30th. Notes indicate that due to public safety for being fearful (and not for attempting to bite someone), she was cleared for euthanasia. How does this support the Hayden act and the welfare of Penelope? To make it more heartbreaking, Penelope was pregnant. She was a baby herself, at 1 year old.

Her public record states that a tranquilizer was given on May 31st for euthanasia. I went in on May 30th to adopt her. You mean to tell me that she was alive when I went to adopt her and shelter staff actively prevented her adoption by lying to me?

Maria stated that this was a late entry completed by the shelter worker, to which I don't believe. Her public record contains lies. This means that all shelter and veterinary notes are compromised and open to scrutiny on all the dogs within their facility. I

demand that her public record be corrected to reflect the truth. Maria and her staff have failed Penelope in addition to countless other dogs. Receit it speaks to a culture of lies, deceit and omission of information that is pervasive within the Riverside County Department of Animal Services. I demand that the Board of Supervisors conduct weekly audits on all 4 campuses. Now (mag.hg) if this were well dog.

How could you let this happen under your watch? Or more importantly, did you already know but turned a blind eye? NBC Palm Springs recently conducted an investigation into RivCo Animal Services, surely you must've known about those allegations? Erin Geddes stated that \$39 million of taxpayer's money is enough to support the shelters, yet there continues to be killings of many dogs without being given a sufficient timeframe of getting adopted, killings of dogs that are hidden from public view (like Penelope) in addition to inadequate medical care and subpar living conditions. Duke had bilateral ear infections and intestinal worms. How long was he going to sit in there until they noticed these things? Duke was also out of view and would have been killed shortly after if I wasn't vigilant in adopting him out of there with a sense of urgency.

October 19, 2022 the following properties were reported in violation of Ordinance 348 Section 3.3 and Ordinance 348 Section 18.2.

October 25,2022 cases were opened on these properties. The Code Enforcement officer assigned to these cases was David DeLeon. In short from this date to July of 2023 NOTHING was done. He opened cases and then closed them as "unfounded" or "in compliance".

There was nothing further from the truth. None of the property owners had complied and violations were NOT CORRECTED. Property owners continued to live in their RV's. All storage was kept on lots and additional storage was added on some of the lots.

On July 24, 2023 I emailed the Supervisor in regards to the ongoing violations. You assigned the ongoing violations to Rick Ramirez. He assured me that he would speak to DeLeon. Still nothing was done. I emailed Rick Ramirez asking him what had been done. He replied "thanks for the consistent messaging and he would let me know". But still nothing was done. On November 29,2023 I reported to Jose Cruz the supervisor and I also sent him photographs of the properties in violation.

Again nothing was done.

February 13,2024 I called Code Enforcement again. I was told that a new officer Jesus Gonzalez was assigned to the properties due to the fact that Officer DeLeon did not follow the steps or do his job.

February 22,2024 I was finally able to speak with Officer Gonzalez after several attempts. He told me that the process had to start all over because DeLeon didn't do his job. Officer Gonzalez told me " if the owners don't comply the cases will go to civil litigation and then if the RV's and storage aren't removed the county will hire a contractor to remove certain items". February 26,2024 Officer Gonzalez and I spoke again. He told me that he had been on all the properties. He also stated, "the fines will be \$100, \$200 and \$500 for the 3rd violation and then the fine increases to \$500 every 2 weeks". He added that "the cases have gone to county council".

March 26,2024 Officer Gonzalez stated, "he was working on all of the cases and if owners don't comply in 4 days the county will apply for a seizure warrant and a lien will be put on their properties."

June 4,2024 I called for an update since it was 3 weeks after owners were told to comply in 4 days and nothing had changed. Officer Gonzalez said, "his bigger problem is in Cherry Valley because more people are complaining". He contradicted what he told me in previous conversations. He said, "they might go to litigation." He then told me that he would be out for 2 months so all future concerns would be handled by James Palmer.

At this point as property owners we are very discouraged with the lack of progress. Everytime we speak to someone from Code Enforcement we get a different story or we are just ignored.

The ongoing violations have now continued for a total of 21 MONTHS. I emailed James Palmer on June 6th and asked him to call me so that we could get some clarification. I have not received a call or email.

Our property value is continuing to fall with owners being allowed to live in their RV's and accumulate excess storage. Our questions to you are the following:

- 1). Why does the County have these Ordinances if you aren't going to enforce them?
- 2). What ARE the steps toward compliance?
- 3). What is going to be done to solve this ongoing blatant violation of the County Ordinances?

Supervisor Yxstian Gutierrez, I am a property owner in Riverside Co. and I have concerns. Zoning Ordinance 348 is continually being violated. Tremont Ranch in Riverside Co. is not a RV park. It is supposed to be a community of 10 acre estates NOT a trailer park.

Violations include: occupied recreational vehicles, excess outside storage, grading without a permit and sewage being dumped into the ground. These violations are occurring on the following parcels- 471-250-019, 471-250-020, 471-250-022, 471-250-030, 471-250-031.

On October 25,2022 cases were opened per code enforcement. I have continued to call about these code violations. I have 12 documented calls.

This has been allowed to continue for 10 months. Our property value continues to decrease.

As the County Supervisor of District 5, what do you plan to do to resolve this situation? We would appreciate you looking into this matter. Please keep our names confidential. Thank you.

c. A deposit equaling 3 hours of the current hourly fee for Review of Covenants, Conditions & Restrictions established pursuant to Ordinance No. 671 at the time the above documents are submitted to the Planning Department for review by County Counsel.

The declaration of covenants, conditions, and restrictions submitted for review shall (a) provide for a minimum term of 60 years, (b) provide for the establishment of a property owners' association comprised of the owners of each individual lot or unit as tenants in common, and (c) provide for the ownership of Streets "B", "C", "D" and the twenty foot easement for a regional recreational trail by either the property owners' association or the owners of each individual lot or unit as tenants in common, and d) contain the following provisions verbatim:

"Notwithstanding any provision in this Declaration to the contrary, the following provisions shall apply:

The property owners' association established herein shall manage and continuously maintain Streets "B", "C", "D" and the twenty foot easement for a regional recreational trail, more particularly described on Exhibit E, attached hereto, and shall not sell or transfer Streets "B", "C", "D" and the twenty foot easement for a regional recreational trail or any part thereof, absent the prior written consent of the Planning Director of the County of Riverside or the County's successor-in-interest.

The property owners' association shall have the right to assess the owners of each individual lot or unit for the reasonable cost of maintaining Streets "B", "C", "D" and the twenty foot easement for a regional recreational trail and shall have the right to lien the property of any such owner who defaults in the payment of a maintenance assessment. As assessment lien, once created, shall be prior to all other liens recorded subsequent to the notice of assessment or other document creating the assessment lien.



This Declaration shall not be terminated, 'substantially' amended, or property deannexed therefrom absent the prior written consent of the Planning Director of the County of Riverside or the County's successor-in-interest. A proposed amendment shall be considered 'substantial' if it affects the extent, usage, or maintenance of Streets "B", "C", "D" and the twenty foot easement for a regional recreational trail.

(Amended at PC: December 15, 1993)

In the event of any conflict between this Declaration and the Articles of Incorporation, the Bylaws, or the property owners' association Rules and Regulations, if any, this Declaration shall control."

Such behavior, at the discretion of the Board Chairman may result in removal from the Board Chambers by Sheriff Deputies.
