

BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development, and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official is responsible for appointing the WDB members for two-year terms.

Carolyn Reyna is the Deputy Division Chief for the Inland Empire counties for the State of California Employment Development Department Workforce Services. She brings over 17 years of experience in the Employment Development Department (EDD). Her responsibilities consisted of managing eight Americas Job Center of California (AJCC), staff and WSB service delivery throughout the Counties. She has developed partnerships that are built on transparency

and has cultivated effective relationships in the workforce community. Under her leadership, EDD staff proactively partner with County staff to provide services at the County's Workforce Development Centers, also known as AJCC's.

Ms. Reyna has expressed interest in serving on the WDB as a Public Sector Wagner-Peyser representative for All Districts. If appointed, she will serve a two-year term commencing April 5, 2024, and expiring April 5, 2026.
