

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Riverside Educational Enrichment Foundation - \$1,000** will be used to support both the Riverside Educational Enrichment Foundation (REEF) and Riverside Unified School District (RUSD) on their mission to provide teacher grants for art projects, field trips, equipment for sports and PE for over 43,000 students.
2. **Riverside Arts Council - \$2,500** will be used to support the Riverside Art & Music Festival, an event designed to showcase the artistic talent of the Riverside County Arts community, it is a free public event.
3. **SAFE Family Justice Centers - \$2,500** will be used to provide emergency shelter, transportation vouchers, and support for their youth programs.
4. **Passion to Love and Care Ministry - \$1,000** will be used to provide essential resources, such as food and clothing, for the homeless and families in need.

- 5. Taking It To The Streets with Lori and Shira - \$2,000** funding will be used to support the homeless with their pets by offering food, supplies for pets and funding for spay/neuter services to the homeless people encountered in Riverside and Jurupa Valley.
- 6. Riverside Medical Charitable Foundation - \$2,000** funding will be used to provide training to educators, law enforcement, youth leaders, and community representatives who are committed to ending bullying.
- 7. Rivers and Lands Conservancy- \$2,000** funding will be used to support the California Native Plant Garden Program Restoration and Expansion at Bryant Park project, to purchase plants, volunteer event supplies, and costs for essential gardening and staff time.
- 8. Riverside County Deputy Sheriff Relief Foundation - \$2,000** funding will be utilized to deliver services aimed at benefiting the families of deputy sheriffs, law enforcement, and public safety officers who have been injured, victims of criminal acts, or killed in the line of duty.
- 9. In-Home Supportive Services Public Authority- \$2,000** to support the two-day event to honor IHSS caregivers. These caregivers play a crucial role in providing essential care and support to our community's most vulnerable population, seniors, and individuals with disabilities.
