

BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. **Community Access Center** - \$1,380- The funds will cover the full cost of the Golf Knolls Community Gate Project.
2. **Murrieta/Wildomar Chamber of Commerce**-\$2,000- This allocation will support the Wildomar State of the City address. An event that brings civic leaders, residents, and businesses together to highlight the city's achievements and the future of the City of Wildomar.
3. **Animal Friends of the Valleys** -\$10,000- The funding will support the Pet Medical Grant Program. A program that provides a veterinary care voucher to low-income third-district residents in need of veterinary services.
4. **Friends of the Anza Valley Community Library**-\$4,950- The funding will be used to support the summer reading program and the mobile library operations throughout the rural areas of Anza, Sage, Aguanga, and the Cahuilla Band of Indians.
5. **VNW Circle of Care, Inc.** -\$10,000- The allocated funds will be used to support the Circle of Care Food Distribution Program. This program provides low-income families in the third district with food boxes.
6. **Riverside Medical Clinic Charitable Foundation**-\$4,000- The funding will be used to support the HERO program. A program that provides bullying prevention materials, parent classes, and activities in Spanish, English, and 5 different Asian languages to third-district students.
7. **Western Center Community Foundation Dba Western Science Center**-\$10,000- This allocation will support the Science Exploration Experience Program. A program that offers students the opportunity to explore the museum's exhibits, attend summer day camps, and learn more about fossil discovery at the Max's Lab.
8. **Riverside County Sheriff's Department** -\$2,500- The funding will be used to support the Heroes Among Us Annual Awards Ceremony. A ceremony that honors officers and community members for their courageous and humanitarian acts of service throughout the county.

9. **Temecula Valley Chamber of Commerce** -\$1,200- The funding will be used to support the 18th Annual Women in Business Conference. An educational event that allows local business leaders to connect and features keynote speeches from industry leaders.
10. **Trauma Intervention Program of Riverside County** -\$1,500- This allocation will support the 17th Annual Heroes with Heart Awards Gala. An event that recognizes first responders and TIP volunteers for their service.
11. **Shuttles 4 Soldiers** -\$20,000- This allocation will provide non-emergency medical appointment transportation to low-income veterans with severe chronic/physical disabilities.
12. **Rotary Club of Temecula Sunrise** -\$9,000- The funding will be utilized to support two programs (1) Literacy Project, a program that helps students learn to read, and (2) Safety Town, a program that teaches young children about stranger danger, fire, water, poisoning, and bicycle safety.
13. **County of Riverside IHSS Public Authority** -\$1,500- The funding will be utilized to support the IHSS Caregiver Appreciation event, an event that will recognize the contribution of the IHSS caregivers.
14. **Professional Women's Roundtable** -\$1,500- The funding will be used to support the 11th Joan Sparkman Unity Award Presentation, an event that provides aspiring women leaders with business resources and scholarships.
