BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. The donation to Riverside Medical Clinic Charitable Foundation (\$4,000.00) will be used to continue improving health and quality of life in Riverside County through advocacy, education and addressing the bullying epidemic through its Annual Bullying Prevention Conference.
- 2. The donation to the Rotary Club of Greater Eastvale (\$3,000.00) will be used to support Rotary Youth Leadership, where youth 14-18 years old develop leadership skills, communication, and mentorship to become dynamic leaders within their school and community.
