RECOMMENDED MOTION: That the Board of Supervisors:

1. Find that the two (2) Funding Agreements ("Agreements") are exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15061(b)(3), the "Common Sense" exemption;
2. Approve the Agreements between the Riverside County Flood Control and Water Conservation District ("District") and the City of Norco ("City");
3. Authorize the Chair of the District's Board of Supervisors to execute the Agreements on behalf of the District;
4. Authorize the General Manager-Chief Engineer or designee to approve, sign and execute any future non-substantive amendments to the Agreements that do not increase the cost to the District and do not materially change the scope of services, subject to approval as to form by County Counsel; and
5. Direct the Clerk of the Board to return two (2) copies of each executed Agreement to the District.



BACKGROUND:

Summary

These two (2) Agreements set forth the terms and conditions by which the District will contribute funding to the City to develop and implement the Norco North Drive and Grulla Storm Drain and Norco Town and Country Drive Storm Drain projects as part of a City administered public works construction contract. Said facilities are to be constructed, inspected, operated and maintained by the City. The District wishes to provide only financial assistance to the City and have no other role.

- Norco North Drive and Grulla Storm Drain: An underground storm drain system that will collect flows from the intersection of Crestview Drive and North Drive and convey them northwesterly into the Santa Ana River.
- Norco Town and Country Drive Storm Drain: An underground storm drain system that will collect flows from Town and County Drive and convey them from Vic Jensen Way and Horseless Carriage Drive to an existing City maintained storm drain in Hamner Avenue.

County Counsel has approved the Agreements as to legal form, and the City has executed the Agreements.

Environmental Findings

The Agreements are exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption), which provides, "The activity is covered by the common-sense exemption that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA." The Agreements do not authorize to any extent whatsoever actual physical development of the underlying property. Such development, if it occurs at all, will be the result of subsequent actions subject to CEQA review by the City prior to construction. The Agreements merely establish the terms by which the District will contribute funding to the City for the construction of the referenced facilities. It can be seen with certainty that there is no possibility the Agreements will have a significant effect on the environment. Therefore, nothing further is required under CEQA.

Impact on Residents and Businesses

The District's financial contribution under these Agreements will be funded by District ad valorem property tax revenues and entail no new fees, taxes or bonded indebtedness to residents and businesses. Upon construction completion, the facilities will reduce street and community flooding for these areas.

Additional Fiscal Information

Pursuant to the Implementing Agreement for the Western Riverside County Multiple Species Habitat Conservation Plan ("MSHCP") executed on June 22, 2004, the District is a participating agency. The District is making a payment to the Western Riverside County Regional Conservation Authority for up to 3% of the total capital cost as required mitigation for the construction of flood control facilities in cooperation with and on behalf of the City. The MSHCP mitigation fee is based on the engineer's estimated project cost, however, the actual 3% payment will be based on the project's lowest responsive contract bid price. The actual mitigation payment that will be made by the District may be reduced based on acquisition of replacement habitat for the benefit of Covered Species, as defined in the Implementing Agreement and MSHCP. The City is the lead agency and MSHCP permittee responsible for compliance with the applicable MSHCP requirements.

The District is providing a total not-to-exceed amount of \$2,766,000 to the City. Sufficient funding is available in the District's Zone 2 budget for FY 2024/2025 and will be included in the proposed budget in future years as appropriate and necessary.

FUNDING AGREEMENT

Norco North Drive and Grulla Storm Drain
Project No. 2-0-10038

This Funding Agreement ("Agreement"), dated as of July 30, 2024, is entered into by and between the RIVERSIDE COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, a body politic ("DISTRICT") and the CITY OF NORCO, a municipal corporation ("CITY"). DISTRICT and CITY are collectively referred to herein as "Parties" and individually as "Party". The Parties hereby agree as follows:

RECITALS

A. DISTRICT has budgeted for, and CITY has prepared plans and specifications ("IMPROVEMENT PLANS") for the construction, operation and maintenance of Norco North Drive and Grulla Storm Drain ("NORTH AND GRULLA STORM DRAIN") to provide drainage improvements for the immediate adjacent areas within CITY; and

B. These IMPROVEMENT PLANS generally consist of the following:

1. NORTH AND GRULLA STORM DRAIN: approximately 2,800 lineal feet of underground storm drain system to reduce street and community flooding. The proposed storm drain pipe will collect flows from intersection of Crestview Drive and North Drive conveying them northwesterly into the Sana Ana River, as shown in blue on Exhibit "A" attached hereto and made a part hereof; and
2. Certain inlets, catch basin and connector pipes associated with NORTH AND GRULLA STORM DRAIN which will be constructed to adequately collect and convey local flows within CITY-held easements or rights of way ("APPURTENANCES"); and

C. Together, NORTH AND GRULLA STORM DRAIN and APPURTENANCES are hereinafter called "PROJECT"; and

D. CITY plans to construct PROJECT in two phases:

1. "PHASE 1", which consists of the portion of PROJECT from the Santa Ana River to the intersection of Grulla Court and California Avenue.
2. "PHASE 2", which consists of the portion of PROJECT from the intersection of Grulla Court and California Avenue to the intersection of Crestview Drive and North Drive. PHASE 1 and PHASE 2 may be referred to individually as a "PHASE" or collectively as the "PHASES"; and

E. CITY plans to advertise, award and administer a public works construction contract for PHASE 1 and PHASE 2 during Fiscal Year 2024/2025; and

F. CITY is willing to assume the lead role for PROJECT and, therefore, will provide the administrative, technical, managerial and support services necessary to plan, design and construct PROJECT; and

G. CITY desires that DISTRICT include certain unavoidable utility relocations as part of DISTRICT's financial contribution to construct PROJECT. "UTILITY RELOCATIONS" is defined as (i) the relocation of CITY owned utilities that conflict with the construction of PROJECT; and (ii) the unavoidable relocation of utilities not owned by CITY that (a) conflict with the construction of PROJECT; and (b) cannot be relocated by others under CITY's franchise authority. UTILITY RELOCATIONS shall be included in the public works construction contract for each PHASE; and

H. CITY desires that DISTRICT contribute funding towards the construction of PROJECT; and

I. DISTRICT wishes to support CITY's efforts to construct PROJECT by providing a financial contribution toward PROJECT's construction along with associated administrative and ancillary costs subject to the not to exceed amount in RECITAL K; and

J. DISTRICT's financial contributions shall be as follows:

1. One hundred percent (100%) of design proposal cost to offset CITY's costs associated with engineering design; hydrology and hydraulics; geotechnical analysis; potholing required to complete the design of PROJECT; California Environmental Quality Act ("CEQA") determination; preparation, application, and acquisition of the environmental clearance and permits if required for PROJECT; and other typical ancillary costs related to the preparation of improvement plans ("DESIGN CONTRIBUTION"). However, DESIGN CONTRIBUTION shall not include the fees associated with the Western Riverside County Multiple Species Habitat Conservation Plan ("MSHCP"); and
2. In the event that CITY chooses to hire an engineering consulting firm to prepare IMPROVEMENT PLANS, DISTRICT is also willing to contribute an additional ten percent (10%) of design proposal cost to offset CITY's administrative costs associated with design contract administration ("DESIGN ADMIN"); and
3. Up to one hundred percent (100%) of the lowest responsive and responsible bid contract amount for the construction of PHASE 1 and the costs associated with UTILITY RELOCATIONS ("PHASE 1 BID PRICE"). In addition, any remaining funds may be used for PHASE 2 as defined below; and

4. Up to one hundred percent (100%) of the lowest responsive and responsible bid contract amount for the construction of PHASE 2 and the costs associated with UTILITY RELOCATIONS ("PHASE 2 BID PRICE").
5. Up to an additional fifteen percent (15%) of PHASE 1 BID PRICE to offset CITY's administrative costs associated with construction, contract administration and other typical ancillary costs related to the delivery of PROJECT ("PHASE 1 CONSTRUCTION ADMINISTRATION CONTRIBUTION"); and
6. Up to an additional fifteen percent (15%) of PHASE 2 BID PRICE to offset CITY's administrative costs associated with construction, contract administration and other typical ancillary costs related to the delivery of PROJECT ("PHASE 2 CONSTRUCTION ADMINISTRATION CONTRIBUTION"); and
7. Up to an additional ten percent (10%) of PHASE 1 BID PRICE for construction contract change orders ("PHASE 1 CONSTRUCTION CHANGE ORDERS CONTRIBUTION"); and
8. Up to an additional ten percent (10%) of PHASE 2 BID PRICE for construction contract change orders ("PHASE 2 CONSTRUCTION CHANGE ORDERS CONTRIBUTION"); and

K. Altogether, DESIGN CONTRIBUTION, DESIGN ADMIN, PHASE 1 BID PRICE, PHASE 2 BID PRICE, PHASE 1 CONSTRUCTION ADMINISTRATION CONTRIBUTION, PHASE 2 CONSTRUCTION ADMINISTRATION CONTRIBUTION, PHASE 1 CONSTRUCTION CHANGE ORDERS CONTRIBUTION, and PHASE 2

CONSTRUCTION CHANGE ORDERS CONTRIBUTION are hereinafter called "TOTAL DISTRICT CONTRIBUTION"; and

L. TOTAL DISTRICT CONTRIBUTION for PROJECT shall not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000); and

M. DISTRICT wishes to provide only financial assistance to CITY and have no other role in PROJECT; and

N. The purpose of this Agreement is to memorialize the mutual understandings by and between CITY and DISTRICT with respect to the construction, ownership, operation and maintenance of PROJECT and the payment of TOTAL DISTRICT CONTRIBUTION.

NOW, THEREFORE, in consideration of the preceding recitals and the mutual covenants hereinafter contained, the Parties hereto mutually agree that the above recitals are true and correct and incorporated into the terms of this Agreement and as follows:

SECTION I

CITY shall:

1. Pursuant to CEQA, act as Lead Agency and assume responsibility for preparation, circulation and adoption of all necessary and appropriate CEQA documents pertaining to the construction, operation and maintenance of PROJECT.

2. Invoice DISTRICT (Attention: Special Projects Section) for fifty percent (50%) of DESIGN CONTRIBUTION upon execution of this Agreement. TOTAL DISTRICT CONTRIBUTION shall not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000) for PROJECT.

3. Prepare or cause to be prepared IMPROVEMENT PLANS for PHASE 1 and PHASE 2, in accordance with the applicable CITY standards.

4. CITY shall make reasonable efforts during the preparation of IMPROVEMENT PLANS to avoid utility conflicts associated with UTILITY RELOCATIONS.

5. Following the signing of IMPROVEMENT PLANS, invoice DISTRICT (Attention: Special Projects Section) for the (i) remaining fifty percent (50%) of DESIGN CONTRIBUTION and (ii) DESIGN ADMIN, and DISTRICT CONTRIBUTION shall not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000).

6. Prior to advertising PROJECT for public works construction contract for each PHASE, obtain all necessary permits, licenses, agreements, approvals, rights of way, rights of entry, encroachment permits, and temporary construction easements as may be needed to construct, operate and maintain PROJECT.

7. Upon execution of this Agreement, advertise, award and administer each PHASE pursuant to the applicable provisions of the California Public Contract Code. At the time of advertising for bids, provide DISTRICT with a copy of IMPROVEMENT PLANS, specifications, bid documents and any subsequent addenda thereto.

8. Provide DISTRICT with written notice (Attention: Special Projects Section) that CITY has awarded a public works construction contract for each PHASE. The written notice shall include the Contractor's actual bid amounts for each PHASE, setting forth the lowest responsible bid contract amount.

9. At the time of providing written notice of the award of a construction contract for PHASE 1, as set forth in Section I.3 and Section I.5, invoice DISTRICT (Attention: Special Projects Section) for PHASE 1 BID PRICE, subject to and provided that TOTAL DISTRICT CONTRIBUTION does not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000) for PROJECT. PHASE 1 BID PRICE shall be supported by a copy of CITY's bid abstracts for PHASE 1.

10. At the time of providing written notice of the award of a construction contract for PHASE 2, as set forth in Section I.11, invoice DISTRICT (Attention: Special Projects Section) for PHASE 2 BID PRICE subject to and provided that TOTAL DISTRICT

CONTRIBUTION does not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000) for the PROJECT. PHASE 2 BID PRICE shall be supported by a copy of CITY's bid abstracts for PHASE 1.

11. Order the relocation of all utilities within CITY rights of way which may conflict with the construction of PROJECT.

12. Procure or caused to be procured insurance coverages during the term of this Agreement. CITY shall require its PROJECT construction contractor(s) for each PHASE to furnish original certificate(s) of insurance and original certified copies of endorsements and, if requested, certified original policies of insurance including all endorsements and any and all other attachments. Prior to CITY issuing a Notice to Proceed to its construction contractor(s) to begin construction of any PHASE, an original certificate of insurance evidencing the required insurance coverage shall be provided to DISTRICT. The procured insurance coverages shall name DISTRICT, County of Riverside, its Agencies, Districts, Special Districts and Departments, their respective directors, officers, Board of Supervisors, employees, elected or appointed officials, agents or representatives as Additional Insured. CITY shall notify DISTRICT of any claim by a third party or any incident or event that may give rise to a claim arising from the performance of this Agreement.

13. Construct or cause to be constructed, each PHASE pursuant to a CITY administered public works contract in accordance with IMPROVEMENT PLANS.

14. Inspect construction of each PHASE or cause each PHASE's construction to be inspected by its construction manager.

15. Require its construction contractor(s) to comply with all Cal/OSHA safety regulations including regulations concerning confined space and maintain a safe working environment for all CITY employees on the site.

16. Upon completion of construction for each PHASE and CITY's acceptance thereof, accept ownership and sole responsibility for the design, inspection, operation and maintenance of PHASE 1 and PHASE 2.

17. Upon completion of construction for each PHASE, provide DISTRICT with a copy of CITY's Notice of Completion for the respective PHASE.

18. Keep an accurate accounting of all PROJECT costs along with PHASE 1 CONSTRUCTION ADMINISTRATION CONTRIBUTION, PHASE 2 CONSTRUCTION ADMINISTRATION CONTRIBUTION, PHASE 1 CONSTRUCTION CHANGE ORDERS CONTRIBUTION and PHASE 2 CONSTRUCTION CHANGE ORDERS CONTRIBUTION, as set forth in RECITAL I. The final accounting of PROJECT costs shall include a detailed breakdown of all costs, including, but not limited to, payment vouchers, CITY approved change orders and other such construction contract documents as may be necessary, to establish the actual cost of construction for DISTRICT and CITY approved IMPROVEMENT PLANS.

19. At the time of providing a Notice of Completion for each PHASE, invoice DISTRICT (Attention: Special Projects Section) for the respective PHASE 1 CONSTRUCTION ADMINISTRATION CONTRIBUTION and PHASE 2 CONSTRUCTION ADMINISTRATION CONTRIBUTION and, if applicable, the respective PHASE 1 CONSTRUCTION CHANGE ORDERS CONTRIBUTION and PHASE 2 CONSTRUCTION CHANGE ORDERS CONTRIBUTION, subject to and provided TOTAL DISTRICT CONTRIBUTION shall not exceed, One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000).

SECTION II

DISTRICT shall:

1. Within thirty (30) days after receipt of CITY's invoices (i) pay all approved CITY's invoices and (ii) review and approve associated documents as described in the

RECITALS and SECTION I of this Agreement, subject to and provided that TOTAL DISTRICT CONTRIBUTION shall not exceed, One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000) for PROJECT.

2. Within thirty (30) days of CITY awarding PROJECT, pay the Western Riverside County Regional Conservation Agency the mitigation fee for PROJECT per the 2004 Implementing Agreement for MSHCP, which is either the lesser of (i) three percent (3%) of the lowest responsible bid; or (ii) three percent (3%) of lowest responsible bid contract price, less the value of any applicable project specific mitigation.

3. Not be responsible to pay any amounts that exceed TOTAL DISTRICT CONTRIBUTION for PROJECT.

SECTION III

It is further mutually agreed:

1. Notwithstanding any other provision herein this Agreement, TOTAL DISTRICT CONTRIBUTION shall not exceed a total sum of One Million Seven Hundred Ninety Thousand Dollars (\$1,790,000) and shall be used by CITY solely for the purpose of constructing PROJECT as set forth herein. No additional funding whatsoever shall be provided by DISTRICT for any subsequent PROJECT modifications, extensions or repairs.

2. In the event the actual construction cost for each PHASE is less than the respective BID PRICE, CITY shall refund the difference to DISTRICT within thirty (30) days of filing the Notice of Completion for that PHASE.

3. Under the provisions of this Agreement, DISTRICT shall bear no responsibility whatsoever for the design, construction, ownership, operation or maintenance of PROJECT.

4. CITY shall indemnify, defend, save and hold harmless DISTRICT and the County of Riverside (including their agencies, districts, special districts and departments, their

respective directors, officers, Board of Supervisors, elected and appointed officials, employees, agents, representatives, independent contractors, and subcontractors) from any liabilities, claim, damage, proceeding or action, present or future, based upon, arising out of or in any way relating to CITY's (including its officers, elected and appointed officials, employees, agents, representatives, independent contractors and subcontract) actual or alleged acts or omissions related to this Agreement, performance under this Agreement or failure to comply with the requirements of this Agreement including, but not limited to (a) property damage; (b) bodily injury or death; (c) payment of attorney fees; or (d) any other element of any kind or nature whatsoever. This section shall survive any termination of this Agreement until the statute of limitations period has run for any claims that could be asserted under this Agreement.

5. If any provision in this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions will nevertheless continue in full force without being impaired or invalidated in any way.

6. This Agreement is to be construed in accordance with the laws of the State of California. Any action at law or in equity brought by any of the Parties hereto for the purpose of enforcing a right or rights provided for by this Agreement shall be tried in a court of competent jurisdiction in the County of Riverside, State of California, and the Parties hereto waive all provisions of law providing for a change of venue in such proceedings to any other county. Neither CITY nor DISTRICT shall assign this Agreement without the written consent of the other Party.

7. This Agreement is made and entered into for the sole protection and benefit of the Parties hereto. No other person or entity shall have any right of action based upon the provisions of this Agreement.

8. Any and all notices sent or required to be sent to the Parties of this Agreement will be mailed by first class mail, postage prepaid, to the following addresses:

9. This Agreement is the result of negotiations between the Parties hereto and the advice and assistance of their respective counsel. The fact that this Agreement was prepared as a matter of convenience by DISTRICT shall have no importance or significance. Any uncertainty or ambiguity in this Agreement shall not be construed against DISTRICT because DISTRICT prepared this Agreement in its final form.

10. Any waiver by DISTRICT or CITY of any breach by any other Party of any provision of this Agreement shall not be construed to be a waiver of any subsequent or other breach of the same or any other provision hereof. Failure on the part of DISTRICT or CITY to require from any other Party exact, full and complete compliance with any of the provisions of this Agreement shall not be construed as in any manner changing the terms hereof or estopping DISTRICT or CITY from enforcing this Agreement.

11. The obligations of DISTRICT are limited by and contingent upon the availability of DISTRICT funds for DISTRICT's financial contribution towards PROJECT as set forth herein. In the event such funds are not forth coming for any reason, DISTRICT shall immediately notify CITY in writing. The Agreement shall be deemed terminated and have no further force and effect immediately upon receipt of DISTRICT's notification by CITY.

12. This Agreement is intended by the Parties hereto as a final expression of their understanding with respect to the subject matter hereof and as a complete and exclusive statement of the terms and conditions thereof and supersedes any and all prior and contemporaneous agreements and understandings, oral or written, in connection therewith. This Agreement may be changed or modified only upon the written consent of the Parties hereto.

13. No alternation or variation of the terms of this Agreement shall be valid unless made in writing and signed by both Parties and no oral understanding or agreement not incorporated herein shall be binding on either Party hereto.

14. Nothing in the provisions of this Agreement is intended to create duties or obligations to or rights in third parties not parties to this Agreement.

15. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument. Each Party of this Agreement agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act ("CUETA") Cal. 



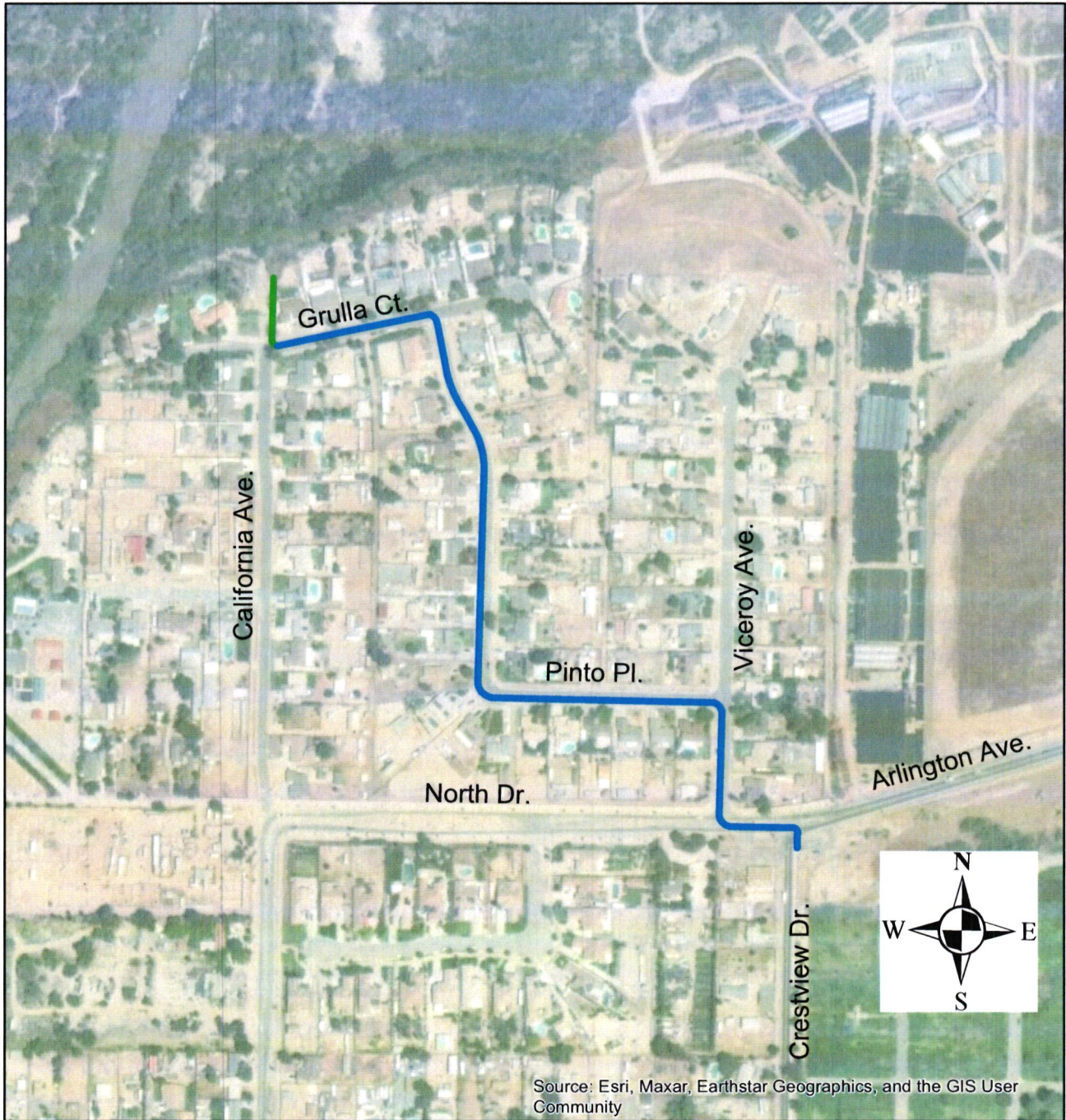

FUNDING AGREEMENT

Norco Town and Country Drive Storm Drain
Project No. 2-0-10043

This Funding Agreement ("Agreement"), dated as of July 30, 2024, is entered into by and between the RIVERSIDE COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, a body politic ("DISTRICT"), and the CITY OF NORCO, a municipal corporation ("CITY"). DISTRICT and CITY are collectively referred to herein as "Parties" and individually as "Party". The Parties hereby agree as follows:

RECITALS

A. DISTRICT has budgeted for and CITY has prepared plans and specifications ("IMPROVEMENT PLANS") for the construction, operation and maintenance of Norco Town and Country Drive Storm Drain ("TOWN AND COUNTRY STORM DRAIN") to provide drainage improvements for the immediate adjacent areas within CITY; and

B. These IMPROVEMENT PLANS generally consist of the following:

1. TOWN AND COUNTRY STORM DRAIN: Approximately 1,500 lineal feet of underground storm drain system within Town and Country Drive to reduce street and community flooding. The proposed storm drain pipe will collect flows from the intersections of Tara Lane and Horseless Carriage, conveying them easterly toward Hamner Avenue, as shown in blue on Exhibit "A" attached hereto and made a part hereof; and
2. Certain inlets, catch basins and connector pipes associated with TOWN AND COUNTRY STORM DRAIN which will be constructed to adequately collect and convey local flows within CITY-held easements or rights of way ("APPURTENANCES"); and

C. Together, TOWN AND COUNTRY STORM DRAIN and APPURTENANCES are hereinafter called "PROJECT"; and

D. CITY plans to advertise, award and administer a public works construction contract for PROJECT during Fiscal Year 2023/2024; and

E. CITY desires that DISTRICT include certain unavoidable utility relocations as part of the DISTRICT's financial contribution to construct PROJECT. "UTILITY RELOCATIONS" is defined as (i) the relocation of CITY owned utilities that conflict with the construction of PROJECT and (ii) the unavoidable relocation of utilities not owned by CITY that (a) conflict with the construction of PROJECT and (b) cannot be relocated by others under CITY's franchise authority; and

F. UTILITY RELOCATIONS shall be included in the public works construction contract for PROJECT; and

G. CITY desires that DISTRICT contribute funding toward the construction of PROJECT; and

H. DISTRICT wishes to support CITY's efforts to construct PROJECT by providing a financial contribution toward PROJECT's construction along with associated administrative and ancillary costs subject to the not to exceed amount in RECITAL K; and

I. DISTRICT's financial contributions shall be as follows:

1. One hundred percent (100%) of design proposal cost to offset CITY's costs associated with engineering design; hydrology and hydraulics; geotechnical analysis; potholing required to complete the design of PROJECT; California Environmental Quality Act ("CEQA") determination; preparation, application and acquisition of the environmental clearance and permits, if required, for PROJECT; and

other typical ancillary costs related to the preparation of improvement plans ("DESIGN CONTRIBUTION"). However, DESIGN CONTRIBUTION shall not include the fees associated with the Western Riverside County Multiple Species Habitat Conservation Plan ("MSHCP"); and

2. In the event that CITY chooses to hire an engineering consulting firm to prepare IMPROVEMENT PLANS, DISTRICT is also willing to contribute an additional ten percent (10%) of design proposal cost to offset CITY's administrative costs associated with design contract administration ("DESIGN ADMIN"); and
3. Up to one hundred percent (100%) of the lowest responsive and responsible bid contract amount for the construction of PROJECT and the costs associated with UTILITY RELOCATIONS ("BID PRICE"); and
4. Up to an additional ten percent (15%) of BID PRICE to offset CITY's administrative cost associated with construction contract administration and other typical ancillary costs related to the delivery of the facility ("CONTRACT ADMINISTRATION CONTRIBUTION"); and
5. Up to an additional ten percent (10%) of BID PRICE for construction contract change orders ("CONSTRUCTION CHANGE ORDERS CONTRIBUTION"); and

J. Altogether, DESIGN CONTRIBUTION, DESIGN ADMIN, BID PRICE, CONTRACT ADMINISTRATION CONTRIBUTION and CONSTRUCTION CHANGE

ORDERS CONTRIBUTION are hereinafter called "TOTAL DISTRICT CONTRIBUTION";
and

K. TOTAL DISTRICT CONTRIBUTION for PROJECT shall not exceed a total sum of Nine Hundred Seventy-Six Thousand Dollars (\$976,000); and

L. DISTRICT wishes to provide only financial assistance to CITY and have no other role in the PROJECT; and

M. The purpose of this Agreement is to memorialize the mutual understandings by and between CITY and DISTRICT with respect to the construction, ownership, operation and maintenance of PROJECT and the payment of TOTAL DISTRICT CONTRIBUTION.

NOW, THEREFORE, in consideration of the preceding recitals and the mutual covenants hereinafter contained, the Parties hereto mutually agree that the above recitals are true and correct and incorporated into the terms of this Agreement and as follows:

SECTION I

CITY shall:

1. Pursuant to CEQA, act as Lead Agency and assume responsibility for preparation, circulation and adoption of all necessary and appropriate CEQA documents pertaining to the construction, operation and maintenance of PROJECT.

2. Invoice DISTRICT (Attention: Special Projects Section) for fifty percent (50%) of DESIGN CONTRIBUTION upon execution of this Agreement. TOTAL DISTRICT CONTRIBUTION shall not exceed a total sum of Nine Hundred Seventy-Six Thousand Dollars (\$976,000) for PROJECT.

3. Prepare or cause to be prepared improvement plans, in accordance with the applicable CITY standards. CITY shall make reasonable efforts during the preparation of IMPROVEMENT PLANS to avoid utility conflicts associated with UTILITY RELOCATIONS.

4. Following the signing of IMPROVEMENT PLANS, invoice DISTRICT (Attention: Special Projects Section) for the (i) remaining fifty percent (50%) of DESIGN CONTRIBUTION and (ii) DESIGN ADMIN and DISTRICT CONTRIBUTION shall not exceed a total sum of Nine Hundred Seventy-Six Thousand Dollars (\$976,000).

5. Prior to advertising PROJECT for public works construction contract, obtain all necessary permits, licenses, agreements, approvals, rights of way, rights of entry, encroachment permits and temporary construction easements as may be needed to construct, operate and maintain PROJECT.

6. Upon execution of this Agreement, advertise, award and administer PROJECT pursuant to the applicable provisions of the California Public Contract Code. At the time of advertising for bids, provide DISTRICT with a copy of IMPROVEMENT PLANS, specifications, bid documents and any subsequent addenda thereto.

7. Provide DISTRICT with written notice (Attention: Special Projects Section) that CITY has awarded a public works construction contract for PROJECT. The written notice shall include the Contractor's actual bid amounts for PROJECT, setting forth the lowest responsible bid contract amount.

8. Order the relocation of all utilities within CITY rights of way that may conflict with the construction of PROJECT.

9. At the time of providing written notice of the award of a construction contract for PROJECT, invoice DISTRICT (Attention: Special Projects Section) for BID PRICE, subject to and provided that TOTAL DISTRICT CONTRIBUTION does not exceed a total sum of Nine Hundred Seventy-Six Thousand Dollars (\$976,000) for PROJECT. BID PRICE shall be supported by a copy of CITY's bid abstracts for PROJECT.

10. Procure or caused to be procured insurance coverages during the term of

this Agreement. CITY shall require its PROJECT construction contractor(s) to furnish original certificate(s) of insurance and original certified copies of endorsements and, if requested, certified original policies of insurance including all endorsements and any and all other attachments. Prior to CITY issuing a Notice to Proceed to its construction contractor(s) to begin construction of PROJECT, an original certificate of insurance evidencing the required insurance coverage shall be provided to DISTRICT. The procured insurance coverages shall name DISTRICT, County of Riverside, its Agencies, Districts, Special Districts and Departments, their respective directors, officers, Board of Supervisors, employees, elected or appointed officials, agents or representatives as Additional Insured. CITY shall notify DISTRICT of any claim by a third party or any incident or event that may give rise to a claim arising from the performance of this Agreement.

11. Construct or cause to be constructed PROJECT pursuant to a CITY administered public works contract in accordance with IMPROVEMENT PLANS.

12. Inspect PROJECT construction or cause PROJECT's construction to be inspected by its construction manager.

13. Require its construction contractor(s) to comply with all Cal/OSHA safety regulations including regulations concerning confined space and maintain a safe working environment for all CITY employees on the site.

14. Upon completion of PROJECT construction and CITY's acceptance thereof, accept ownership and sole responsibility for the design, inspection, operation and maintenance of PROJECT.

15. Upon completion of PROJECT construction, provide DISTRICT with a copy of CITY's Notice of Completion.

16. Keep an accurate accounting of all PROJECT costs along with CONTRACT ADMINISTRATION CONTRIBUTION and CONSTRUCTION CHANGE ORDERS CONTRIBUTION. The final accounting of construction costs shall include a detailed breakdown of all costs, including, but not limited to, payment vouchers, CITY approved change orders and other such construction contract documents as may be necessary to establish the actual cost of construction for DISTRICT and CITY approved IMPROVEMENT PLANS.

17. At the time of providing a Notice of Completion, invoice DISTRICT (Attention: Special Projects Section) for DISTRICT's CONTRACT ADMINISTRATION CONTRIBUTION and, if applicable, DISTRICT's CONSTRUCTION CHANGE ORDERS CONTRIBUTION, subject to and provided TOTAL DISTRICT CONTRIBUTION shall not exceed Nine Hundred Seventy-Six Thousand Dollars (\$976,000).

SECTION II

DISTRICT shall:

1. Within thirty (30) days after receipt of CITY's invoices, (i) pay all approved CITY's invoices and (ii) review and approve associated documents as described in the RECITALS and SECTION I of this Agreement, subject to and provided that TOTAL DISTRICT CONTRIBUTION shall not exceed Nine Hundred Seventy-Six Thousand Dollars (\$976,000) for PROJECT.

2. Within thirty (30) days of CITY awarding PROJECT, pay the Western Riverside County Regional Conservation Agency the mitigation fee for PROJECT per the 2004 Implementing Agreement for MSHCP, which is either the lesser of (i) three percent (3%) of the lowest responsible bid or (ii) three percent (3%) of lowest responsible bid contract price, less the value of any applicable project specific mitigation.

3. Not be responsible to pay any amounts that exceed TOTAL DISTRICT CONTRIBUTION for PROJECT.

SECTION III

It is further mutually agreed:

1. Notwithstanding any other provision herein this Agreement, TOTAL DISTRICT CONTRIBUTION shall not exceed a total sum of Nine Hundred Seventy-Six Thousand Dollars (\$976,000) and shall be used by CITY solely for the purpose of design and constructing PROJECT as set forth herein. No additional funding whatsoever shall be provided by DISTRICT for any subsequent PROJECT modifications, extensions or repairs.

2. In the event the actual construction cost for PROJECT is less than BID PRICE, CITY shall refund the difference to DISTRICT within thirty (30) days of filing the Notice of Completion for PROJECT.

3. Under the provisions of this Agreement, DISTRICT shall bear no responsibility whatsoever for the design, construction, ownership, operation or maintenance of PROJECT.

4. CITY shall indemnify, defend, save and hold harmless DISTRICT and the County of Riverside (including their agencies, districts, special districts and departments, their respective directors, officers, Board of Supervisors, elected and appointed officials, employees, agents, representatives, independent contractors, and subcontractors) from any liabilities, claim, damage, proceeding or action, present or future, based upon, arising out of or in any way relating to CITY's (including its officers, elected and appointed officials, employees, agents, representatives, independent contractors and subcontractors) actual or alleged acts or omissions related to this Agreement, performance under this Agreement or failure to comply with the requirements of this Agreement, including, but not limited to (a) property damage; (b) bodily

injury or death; (c) payment of attorney fees or (d) any other element of any kind or nature whatsoever. This section shall survive any termination of this Agreement until the statute of limitations period has run for any claims that could be asserted under this Agreement.

5. If any provision in this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions will nevertheless continue in full force without being impaired or invalidated in any way.

6. This Agreement is to be construed in accordance with the laws of the State of California. Any action at law or in equity brought by any of the Parties hereto for the purpose of enforcing a right or rights provided for by this Agreement shall be tried in a court of competent jurisdiction in the County of Riverside, State of California, and the Parties hereto waive all provisions of law providing for a change of venue in such proceedings to any other county. Neither CITY nor DISTRICT shall assign this Agreement without the written consent of the other party.

7. This Agreement is made and entered into for the sole protection and benefit of the Parties hereto. No other person or entity shall have any right of action based upon the provisions of this Agreement.

8. Any and all notices sent or required to be sent to the Parties of this Agreement will be mailed by first class mail, postage prepaid, to the following addresses:

9. This Agreement is the result of negotiations between the Parties hereto and the advice and assistance of their respective counsel. The fact that this Agreement was prepared as a matter of convenience by DISTRICT shall have no importance or significance. Any

uncertainty or ambiguity in this Agreement shall not be construed against DISTRICT because DISTRICT prepared this Agreement in its final form.

10. Any waiver by DISTRICT or CITY of any breach by any other Party of any provision of this Agreement shall not be construed to be a waiver of any subsequent or other breach of the same or any other provision hereof. Failure on the part of DISTRICT or CITY to require from any other Party exact, full and complete compliance with any of the provisions of this Agreement shall not be construed as in any manner changing the terms hereof or estopping DISTRICT or CITY from enforcing this Agreement.

11. The obligations of DISTRICT are limited by and contingent upon the availability of DISTRICT funds for DISTRICT's financial contribution toward PROJECT as set forth herein. In the event such funds are not forth coming for any reason, DISTRICT shall immediately notify CITY in writing. The Agreement shall be deemed terminated and have no further force and effect immediately upon receipt of DISTRICT's notification by CITY.

12. This Agreement is intended by the Parties hereto as a final expression of their understanding with respect to the subject matter hereof and as a complete and exclusive statement of the terms and conditions thereof and supersedes any and all prior and contemporaneous agreements and understandings, oral or written, in connection therewith. This Agreement may be changed or modified only upon the written consent of the Parties hereto.

13. No alternation or variation of the terms of this Agreement shall be valid unless made in writing and signed by both Parties and no oral understanding or agreement not incorporated herein shall be binding on either Party hereto.

14. Nothing in the provisions of this Agreement is intended to create duties or obligations to or rights in third parties not parties to this Agreement.

15. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument. Each Party of this Agreement agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act ("CUETA") Cal. Civ. Code §§ 1633.1 to 1633.17), for executing this Agreement.
