#### **BACKGROUND:**

## Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the above-described Chapter 8 Agreement of Sale of delinquent real property, effective June 1, 2021. The deed conveying title to the purchasers at the auction was recorded June 25, 2021. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on August 25, 2021 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received three claims for excess proceeds:

- 1. Claim from the Internal Revenue Service based on a Notice of Federal Tax Lien recorded December 12, 2018 as Instrument No. 2018-0483488.
- 2. Claim from Robertson's based on an Abstract of Judgment recorded July 24, 2019 as Instrument No. 2019-0276598.
- 3. Claim from Jose L. Ramirez based on a Grant Deed recorded September 16, 2005 as Instrument No. 2005-0766679.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that the Internal Revenue Service be awarded excess proceeds in the amount of \$3,237.37. Because the amount claimed by the Internal Revenue Service exceeds the amount of excess proceeds available, there are no funds for consideration for the claims from Robertson's and Jose L. Ramirez. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.


