BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Boys Scouts of America Troop 322 is receiving Community Improvement Designation Funds (CID) in the amount of \$3,000. Funds will be used for educational activities and to purchase uniforms and supplies.
2. JAAF Beaumont Cougars Football and Cheer is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funds will be used to help pay for the usage of the football field.
3. Inland Empire Community Foundation is receiving Community Improvement Designation Funds (CID) in the amount of \$10,000. Funds will support the cost of the facility for the CIELO Fund's Annual Celebration Brunch Event.
