BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to Soroptimist International of Corona (\$4,000.00) will be used to support scholarships, workshops, and mentorship of young girls within the region.
2. The donation to Amber Waves of Grain (\$4,000.00) will be used to support various local veterans organizations and the annual Christmas Dinner for homeless veterans.
3. The donation to Trauma Interventions Programs (TIP) of S.W. Riverside County (\$1,500.00) will continue to assist with emotional and practical first aid support to the victims and survivors of tragic incidents. TIP continues to serve as the liaison between survivors and emergency responders.
4. The donation to Support Sisterz (\$5,000.00) will be used to support women during cancer treatment and surgeries with medication costs, provide food for their families, cover insurance co-payments, and provide awareness about early detection.

5. The donation to Reaching New Heights (\$5,000.00) will support the Veterans Standdown Resource Event to offer services to the homeless and at-risk veteran population by assistance with employment and access to training programs, housing, and resources.
6. The donation to Christian Arts & Theatre of Corona (\$5,000.00) will be used to support our community with arts education and build relationships with the community and Corona-Norco Unified School District as well as student scholarships and helping to bridge the gap for low- and moderate-income students and families.
7. The donation to the Norco Area Chamber of Commerce (\$1,500.00) will be used to support engagement in various projects and services provided to local businesses including the Workforce Development Program, Business Support Services, and Community programs and outreach.
8. The donation to the Rubidoux High School Choir (\$2,000.00) will support the long-standing choir program to accumulate the materials needed for students and alleviate and financial limitations that the program may experience in their support of teaching music to students.
9. The donation to the Inland Empire Blue Belles (\$1,000.00) will be used to continue supporting female law enforcement and the family of law enforcement dedicated to the emotional and professional support of those who serve and protect.
10. The donation to Jurupa Valley High School (\$2,000.00) will be used to support the Level Up: Attendance Improvement Awards to continue removing barriers that hinder student attendance and ensure that they feel safe and motivated to achieve academic success.
11. The donation to Voices for Children (\$4,000.00) will continue supporting the Court Appointed Special Advocate (CASA) Program for children who have experienced traumatic experiences in the form of child abuse and neglect at the hands of a caregiver or parent through advocacy and intervention.
12. The donation to the Eastvale Chamber of Commerce (\$1,500.00) will support the growth and prosperity of Eastvale and its business through commercial, economic, and cultural development.
13. The donation to the City of Canyon Lake (\$1,500.00) will be used to support public services that sustain and enhance the quality of life for residents through programs that address the community's needs.

The donation to the Riverside Rape Area Crisis Center (\$2,500.00) will be used to continue providing culturally responsive and inclusive advocacy, support, and services to survivors and families affected by sexual violence and provide community education to achieve awareness and prevention of sexual violence and assault.
16. The donation to the County of Riverside – IHSS Public Authority (\$2,000.00) will support the 2024 Caregiver Appreciation Event which provides appreciation to IHSS caregivers who work with elderly and dependent adults as well as provide resources and information.
