BACKGROUND:

Summary

The Riverside County Sheriff's Office (RSO) is seeking approval to purchase the Rapid Containment Baton (RCB), holsters and related accessories from Peacekeeper Products International, LLC (Peacekeeper). On March 10, 2020 (Minute Order 3.33), the County of Riverside Board of Supervisors (Board) approved the purchase of these products with Peacekeeper without seeking competitive bids for five years.

Peacekeeper has provided RSO a Sole Source Justification letter confirming they are the sole manufacturer and provider of The Peacekeeper Rapid Containment Expandable Batons, True Fit Holsters, Secure Lock Rotational Holsters, and related accessories.

Peacekeeper manufactures the only expandable baton with machine milled strike tubes which maintains the tube wall thickness throughout the length of the baton to avoid the baton from collapsing while in use. The RCB has a patented Joint Lock design to reduce the chance of inadvertently collapsing when properly expanded. The RCB has a weight distribution that requires less energy to achieve higher impact, increasing deputy safety and minimizing the amount of strikes necessary for compliance. These unique features reduce the likelihood of ineffective force.

Impact on Residents and Businesses

There is no negative impact on residents and businesses. The use of the RCB will aid deputies in subduing suspects with fewer injuries to the suspects and deputies.

Contract History and Price Reasonableness

On March 10, 2020 (M.O.#3.33, SSJ#20-095), the Board approved the purchase of expandable batons with Peacekeeper for an aggregate amount of \$401,500, inclusive of a 10% contingency, and effective through June 30, 2024.

RSO is currently requesting that the Board approve Peacekeeper's Renewal Letter, effective July 1, 2024 through June 30, 2029.

Peacekeeper has agreed to continue to offer quantity discounts, as listed below, for the purchase of the products and RSO continues to experience an increased demand for these

items. The increased demand is due to the mandate in Penal Code (PC) 830.1 to arm Corrections staff with batons with holsters. Peacekeeper does not anticipate a significant price increase in their products and will increase pricing only if/when necessary, by providing a thirty (30) day written notice to RSO indicating the price increase and period of firm pricing.

Discounted breakdown

- 5% discount on the purchase of 100 to 199 batons and holsters
- 7.5% discount on the purchase of 200 to 499 batons and holsters
- 10% discount on the purchase of 500 to 999 batons and holsters
- 12.5% discount on the purchase of 1,000 to 1,999 batons and holsters
- 15% discount on the purchase of 2,000 or more batons and holsters

If necessary, Peacekeeper will give a minimum 30 day notice of any price changes that maybe necessary outside our annual pricing. Regardless of a possible or necessary price increase, Peacekeeper Products International will continue to honor the above extended discount structure based on the current annual Peacekeeper Commercial Pricelist.

PEACEKEEPER BATONS: Limited Lifetime Warranty

1. Peacekeeper Products International, LLC (Peacekeeper) warrants the Rapid Containment Expandable Baton (R.C.B.) to be free from defects in materials and workmanship under this Limited Lifetime Warranty. No warranties, either expressed or implied, are made as to merchantability or fitness for a particular purpose.
2. Peacekeeper Products International warrants the handle tube, center tube, and primary striking tube against cracking, bending or separating for the Life of the baton when employed in actual confrontations against the approved muscle groups on the human body. The obligation under this warranty is limited to the repair or replacement of the defective unit or portion thereof which is returned to Peacekeeper.
3. For replacement or repair under the Limited Lifetime Warranty, the purchaser must submit a copy of a "Use of Force report" detailing the circumstances in which the damage occurred. Such warranty work will be performed free of charge to the customer. Buyer's remedy for claims arising under this document shall only be for damages, which shall not exceed the price of the product. Peacekeeper may, at its sole election, choose to repair or replace said product. Use of the product outside its recommended design parameters voids all warranties. Warranties apply only to the original end user providing the Baton warranty registration information is provided to the company within 30 days of purchase.

4. To validate the Warranty, the end user must register online at: www.PeacekeeperProducts.com/Warranty, and submit the number on the Baton Insert provided on each baton, or in each box of batons. If the baton is not registered, there may be a charge for repair or replacement or the Company may not elect to warrant the RCB Baton.
5. Peacekeeper's obligation under this warranty is for One Year after date of purchase on baton grip, grip ring, anti-rattle ring insert, and retention spring, and found by Peacekeeper to be defective in materials or workmanship.

HOLSTERS and END CAPS: One Year Warranty

1. Peacekeeper Holsters and End caps are warranted for one year. The obligation under this warranty is limited to the repair or replacement of the defective unit or portion thereof, which is returned to Peacekeeper. Peacekeeper may, at its own option, choose to repair or replace said product. Use of the product outside its recommended design parameters voids all warranties.

The original purchaser must NOT send a Baton, Holster, End Cap, or related product to the company for repair under this warranty without prior approval. Any repair or return not authorized will be refused. The obligation under this warranty is limited to the repair or replacement of the defective unit or portion thereof which is returned. Peacekeeper may be contacted at (909) 596-6699 by email Shipping@PeacekeeperProducts.com, or by mail at 2435 Pine St., Pomona, CA 91767, USA.

- **Nearly all questions or concerns for repair can usually and easily be handled over the phone.**
- **All returns, whether for repair or replacement must have a return authorization (RA) number.**

Please call our office to get this RA number. We will need the invoice number from our packing slip when you call for the RA number. All returns for credit will be inspected and evaluated for resale potential. If the product is unacceptable, it will be returned to the sender at sender's expense and no refund will be given. All shipping charges related to any repair or return, to and from the Company, will be the customer's responsibility.

 - a. Describe the goods/service being requested: Rapid Containment Batons (RCBs) and holsters are requested for all Sworn Academy recruits upon graduation and Correctional staff who meet the requirements of the California Penal Code 830.1.
 - b. Explain the unique features of the goods/services being requested from this supplier:
RCB Batons:
 - The baton's weight is located at the striking area instead of the handle, allowing rapid containment.
 - It is made of durable, high-quality ¾" machined steel that won't bend like other batons.
 - The baton can be expanded in confined spaces by pulling on the tip. Its larger end cap reduces the risk of lacerations or impalement.

- Due to its unique design, the baton collapses easily without continually driving it into the concrete.
- The baton has a large patented joint lock that reduces the chances of inadvertent collapsing.
 - Peacekeeper Expandable Baton with US Patent# 6056643 – Assigned 02/14/2013.
 - Method and Apparatus for Multi-Positional Locking Holster (Secure Lock Rotational Holster with US Patent No. 8,100,304)
- RCB is strong enough to break a vehicle window without the risk of bending or damaging the baton.

Holsters (approved for the Peacekeeper RCB Expandable Baton)

- Peacekeeper's True Fit Holsters are available in Plain, Basketweave, Clarino (high gloss) Leather and Ballistic Nylon.

By offering a less-lethal alternative to firearms, RCBs help the department comply with legal requirements governing the use of force, mitigating the risk of excessive force allegations or legal liabilities.

In response to PC 830.1's mandate, Peacekeeper offers up to 15% quantity discounts on all its products. This enables the department to equip its personnel with department-approved batons efficiently and affordably. Peacekeeper provides a limited lifetime warranty on the RCB baton; therefore, RSO is covered against defects in material and craftsmanship, with free replacement or repair in the rare event of damage sustained during confrontations. A one-year holsters and end caps warranty also provide comprehensive protection for agency investments. To



Features of the Peacekeeper Rapid Containment expandable Baton (RCB):

1. Expandable Baton must be of friction lock design and contain no bearings, cams, or moving parts.
2. Expandable baton must have Primary Strike tubes made from 4130 steel and be completely "Machined", not formed or heat treated. (It should be noted that an 1 ¼" 4130 steel tube baton is much stronger than a 1 inch 4140 steel tube baton.)
3. Expandable baton must be perimeter weighted, having greater weight and mass in the primary strike tube rather than in the handle.
4. Expandable Baton must have a minimum grip diameter of 1 1/4" in diameter.
5. Expandable Baton Grip must be made from Santoprene Rubber, not foam.
6. Expandable Baton must have the ability to be expanded in tight quarters or in confined space by grabbing the tip of the baton.
7. Baton must have a broad End Cap with a minimum flat surface of ¾ inches.
8. RCB Batons have a patented Joint Lock design to reduce the chance of inadvertent collapsing when properly expanded.
9. RCB Batons come with a limited Lifetime Warranty against bending, cracking, or separation of the strike tubes.
10. RCB Batons are 100% made in the U.S.A.

Features of Peacekeeper Secure Lock Rotational Holsters:

1. All Secure Lock Rotational Holsters must have the ability to rotate the holster 0, 30, 60, or 90 degrees in either direction at the push of a button.
2. All Secure Lock Rotational Holsters have the ability to lock the holster in each indexed position once a button is released.
3. All Secure Lock Rotational Holsters must have the ability to receive an RCB baton in the expanded mode.

Features of Peacekeeper True Fit Leather Holsters:

1. All True Fit Leather Holsters are made specifically by Peacekeeper for RCB expandable batons.
2. All True Fit Leather Holsters must be open on the bottom of the holster to receive the RCB in the expanded mode.
3. All True Fit Leather Holsters must have a snapped tab on the bottom of the baton holster to have the ability to receive an RCB baton in the expanded mode.

Features of Peacekeeper True Fit Nylon Holsters:

1. All True Fit Nylon Holsters must be made from 1000 Denier Ballistic Nylon, not Cordura Nylon.
2. Ballistic Nylon Holsters must have rigid backing for strong support.
3. Ballistic Nylon Holsters must have an Easy-On Velcro fastening system.

4. All Ballistic Nylon Holsters must have a snapped tab on the bottom of the baton holster to have the ability to receive an RCB baton in the expanded mode.
