# BACKGROUND:

## Summary 5 1

This Project will reduce street and community flooding in the Woodcrest – Rinehart Acres subdivision. The Project proposes approximately 10,250 feet of drainage related street improvements and 8,000 feet of underground storm drain improvements ranging in diameter from 18 inches to 66 inches to collect flows from the streets of Mariposa Avenue, Granite Avenue, Boulder Avenue, Dallas Avenue, Obsidian Drive and Wood Road and convey them to their natural outlet southeast of the Wood Road and Dallas Avenue intersection. The street improvements identified for this Project are necessary to collect and convey runoff to the proposed storm drains (see attached Project Description and Location Map).

On March 5, 2024 [Agenda Item 11.3], the District's Board adopted a Mitigated Negative Declaration ("MND") and Mitigation Monitoring and Reporting Program for the Woodcrest – Rinehart Acres Drainage Plan Project (SCH #2023090666) based on the findings incorporated into the Initial Study. The Board further concluded that the Project will not have a significant effect on the environment with the incorporation of feasible mitigation, in compliance with CEQA, and directed the Clerk of the Board to file the Notice of Determination ("NOD") with the County Clerk and the Office of Planning and Research within five (5) days of Project approval and authorized the District to proceed with the Project. No legal challenges were received during the 30-day NOD statute of limitations. The Plans and Specifications and Contract Documents being approved today are implementing what was already evaluated under CEQA and are consistent with the Project description in the MND as adopted by the Board.

On August 29, 2023 [Agenda Item 11.3], the District's Board approved the Cooperative Agreement between the District and the County of Riverside for the Project. The Cooperative Agreement sets forth the terms and conditions by which the District and the County of Riverside have agreed upon regarding the design, construction, maintenance and funding of the Project.


