BACKGROUND:

Summary

Lake Skinner Recreation Area (Lake Skinner) provides a variety of outdoor recreation opportunities for western Riverside County including campgrounds, day use areas, playgrounds, splash pads, camp store, two boat launch areas, fish cleaning facility, and storage for recreational vehicles, trailers, and automobiles.

To take advantage of economies of scale, Riverside County Regional Park and Open-Space District (RivCoParks) combined three projects, one of which is being primarily managed for RivCoParks by Riverside County Transportation (Transportation) per a Service Agreement approved by Minute Order 13.1 on July 18, 2023 (Roadway Rehabilitation). While RivCoParks will be responsible for advertising for bids and hiring the contractor, Transportation will continue to support RivCoParks during construction. The projects include the following:

- 1. Boat Launch No. 1 Upgrades: Upgrades to the boat launch ramp and related infrastructure, ADA improvements, upgrades to the fish cleaning stations, parking lot improvements, and signage;
- 2. Water Valve Update: Replacement of inoperable or outdated water valves throughout Park; and
- 3. Roadway Rehabilitation: Repair and application of asphalt pavement and sealer of approximately 1.8 miles of internal roadways and parking area.

Construction bid documents have been approved-as-to-form by County Counsel.

Impact on Residents and Businesses

The Project will provide residents and visitors of the Lake Skinner Recreation Area with an upgraded ADA accessible boat launch facility, smooth roadways, and eliminate the water shutdowns for repair. Re-pavement of the roads will require a temporary shutdown of the Recreation Area for approximately two-weeks.

Additional Fiscal Information

American Rescue Plan Act (ARPA) funds in the amount of \$6,300,000 were allocated to this project on three different occasions for each of the above listed projects. They include an allocation of 3,000,000 on May 23, 2023, by Minute Order 13.1, an allocation of \$1,800,000 on

October 4, 2022 by Minute Order 13.1, and an allocation of \$1,500,000 on October 4, 2022 by Minute Order 13.1. This project is partially funded by the Third District's ARPA allocation.

CEQA Considerations

The Riverside County Regional Park & Open-Space District staff conducted a review of the project and determined that the project qualifies for a Class 1 Categorical Exemption under Section 15301(c) of the State CEQA Guidelines, Article 19 commencing with Section 15300. In accordance with Section 15301(c), Class 1 projects consist of the operation, repair, and maintenance of existing public facilities, such as highways, streets, sidewalks, gutters, bicycle and pedestrian trails and similar facilities. Therefore, the project's proposed improvements to the existing roadways are considered a Class 1 operation and maintenance project.

Staff therefore recommends that the Board of Directors (Board) find that the project is exempt under CEQA and direct the Clerk of the Board to file the Notice of Exemption with the County Clerk and the State Clearinghouse for posting within five (5) working days of this Board meeting with a posting period of not less than 30 days.

The project generally consists of the construction of: Scope 1: Boat Launch Area - Replace existing restroom and fish cleaning station, rework 2 boat launch lanes, ADA accessibility work, parking lot and stormwater improvements; Scope 2: Water Valve Replacements - Replace below-surface water valves, above-ground backflow preventers, and associated cages with concrete foundations; Scope 3: Asphalt road and parking lot replacement and line striping including grading work.

The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, California, for the type of work performed and the locality in which the work is to be performed, per sections 1770 et seq. of the CA Labor Code. **Prevailing wage** rates are on file at the District and are available on request or at: www.dir.ca.gov/oprl/statistics and databases.html. Bidders and Bidders' subcontractors shall comply with the **DIR registration** and qualification requirements per sections 1725.5 and 1771.1 of the CA Labor Code.

Each bid must be submitted on the bid form provided in the bid documents and accompanied by a satisfactory Bid Bond executed by the bidder and surety company, or certified check, or cashier's check in favor of the Riverside County Regional Park and Open-Space District, or cash, in an amount equal to ten percent (10%) of the bid.
