### BACKGROUND:

#### Summary

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution Number 2024-005 adopted July 9, 2024, the Board of Supervisors gave notice of a public hearing for August 27, 2024, to receive testimony regarding the Annexation of Street Lighting Zone 174 to Landscaping and Lighting Maintenance District Number 89-1-Consolidated (L&LMD Number 89-1-C). Annexation of Street Lighting Zone 174 will fund the maintenance and servicing of streetlights within public rights-of-way located Northerly of Winchester Hill Drive, Southerly of Olive Avenue, Easterly of Briggs Road, and Westerly of Leon Road in the Winchester area and includes 58 parcels.

The annexation of territory to an existing assessment district formed under the Landscaping and Lighting Act is a change of organization that requires a public hearing as part of the annexation process. Str. & H. Code §§ 22605(a), 22607, 22588; Gov't. Code § 53753(d).

On July 10, 2024 a notice of the public hearing and information sheet, a mail-in assessment ballot, an impartial analysis, and a copy of Resolution Number 2024-005 was mailed to all property owners within Street Lighting Zone 174, proposed for annexation to L&LMD Number 89-1-C. Pursuant to the notice, all assessment ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution Number 2024-005 in an appropriate newspaper at least ten (10) days prior to the public hearing date and by posting a certified copy of Resolution Number 2024-005 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two (2) other public locations within the County.

#### Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of streetlights within public right-of-way.

Only the residential property owners within the proposed boundaries of Street Lighting Zone 174, which are represented by Tract 30266-1 (TR30266-1), as described in the attached Exhibit "A" (a two-page exhibit containing a description and diagram) are impacted by the cost

of this annexation. The property owners within the proposed boundaries of Street Lighting Zone 174 have petitioned the County of Riverside to annex their property to L&LMD Number 89-1-C and understand that this annexation will result in an assessment on their property to fund the maintenance and servicing of the aforementioned improvements (streetlights).

### SUPPLEMENTAL:

#### **Additional Fiscal Information**

The proposed budget for fiscal year 2025-2026 for Street Lighting Zone 174 is \$4,871. This will result in an assessment for fiscal year 2025-2026 within Street Lighting Zone 174 of \$84 per parcel. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers for electricity for electricity (CPI-U\_Electricity), if any, as it stands as of March of each year over the base index for March of 2024.


# **STREET LIGHT ZONE 174**
